0. 0. Prerequisites

0.1 Legal environment

0.1.1 Responsibility for collecting, processing, and disseminating statistics

The State Committee of the Republic of Uzbekistan on Statistics

The State Committee of the Republic of Uzbekistan on Statistics acts independently in accordance with the Law of the Republic of Uzbekistan “On Official Statistics” adopted on August 11, 2021.

The purpose of the Law is to regulate relations in the field of official statistics. This Law applies to producers and users of official statistics, respondents and suppliers of administrative data, as well as relations arising between them related to the production, dissemination and coordination of official statistics.

On September 2, 2017, the “Regulation on the State Committee of the Republic of Uzbekistan on Statistics” was approved, which defines the mandate, functions and structure of the State Committee of the Republic of Uzbekistan on Statistics, which is the main body responsible for coordination, monitoring and supervision of the National Statistical System, as well as for collecting , processing, analysis and dissemination of data. Its functions include providing a unified statistical methodology that meets international standards.

The State Statistics Committee, like other state statistics bodies carrying out statistical work, has the right, within the limits of its authority, to request

and receive state statistical reports, administrative records and other data necessary for conducting state statistical observations, as well as explanations attached to the reports of other bodies.

According to Presidential Executive Order No. 5054 of September 12, 2017, economic and financial data in the country must be consistent and coordinated within the framework of the IMF's enhanced General Data Dissemination System (r-GDDS).

In April 2019, the Resolution of the President of the Republic of Uzbekistan "On additional measures to ensure openness and transparency of public administration, as well as increasing the statistical potential of the country" PP-4273 was adopted, according to which a subdivision responsible for coordination activities of state bodies and organizations for the formation, maintenance and updating of the list on the Open Data Portal of the Republic of Uzbekistan.

By the Decree of the President of the Republic of Uzbekistan dated August 03, 2020 No. PP-4796 "On measures to further improve and develop the national system of statistics of the Republic of Uzbekistan", in order to ensure the independence of state statistics bodies, increase the objectivity and reliability of statistical information, priority areas for improving the national

statistics system were identified Of the Republic of Uzbekistan and approved the National Strategy for the Development of Statistics of the Republic of Uzbekistan in 2020-2025.

0.1.2 Data sharing and coordination among data producing agencies

In accordance with Article 9 of the Law "On Official Statistics", the State Statistics Committee of the Republic of Uzbekistan is an authorized state body in the field of official statistics, implementing state policy in the field of official statistics and coordinating the development of statistical programs.

State statistics bodies carry out integration with information systems of state and economic management bodies, as well as local executive bodies in order to conduct statistical observations, form and analyze official statistical data; develop measures for the coordinated dissemination of official statistics within the national statistical system.

Other producers of official statistics that are part of the national statistical system create subdivisions responsible for generating statistical data and ensuring information exchange with the authorized state body.

Producers of official statistics and providers of administrative data provide the authorized state body with the available statistical and administrative data free of charge in the manner and terms established by statistical programs.

The Statistical Council is a collegial advisory body on the development, functioning and coordination of official statistics under the authorized state body.

The composition of the Statistical Council is approved by the President of the Republic of Uzbekistan.

0.1.3 Confidentiality of individual reporters' data

State Committee of the Republic of Uzbekistan on Statistics

In accordance with Article 29 of the Law "On Official Statistics", statistical data collected, processed and stored for the production of official statistics are confidential if they allow direct or indirect identification of individuals or legal entities and disclose individual data concerning them.

The Regulation "On the State Committee of the Republic of Uzbekistan on Statistics" (No. 690, September 2017) provides that the State Statistics Committee takes security measures to prevent confidentiality issues, including bank secrecy.

In accordance with Article 35 of the Law "On Official Statistics, interference of state bodies, their officials, as well as other persons in the formation of statistical methodology is not allowed.

The State Statistics Committee employees must follow the code of ethics, including the oath of secrecy, not to disclose any information provided to them in the performance of their duties. They are informed of the responsibilities at the time of appointment. Each employee of The State Statistics Committee is obliged to sign an agreement that obliges him not to disclose such data.

0.1.4 Provision of statistical reporting

State Committee of the Republic of Uzbekistan on Statistics

The State Statistics Committee follows the United Nations Economic Commission for Europe's General Statistical Business Process Model (BMSP)

(UNECE), which lists the statistical business processes that support quality management and

metadata management.

To ensure that the respondents provide information, state statistics bodies, within the limits of their powers, have the right to request and receive from financial, customs, tax authorities, banks, other departments and services, legal entities and their representative offices and branches, individuals, including individual entrepreneurs, information, necessary for the conduct of State statistical observation (at any stage of their development), as well as explanations attached to the reports, and use them for statistical purposes.

In addition, state statistics checks the reliability of statistical data at enterprises, organisations and institutions, conducts an expert analysis of the completeness and objectivity of the statistical data obtained, and in cases of violations, gives instructions necessary to correct them, and makes appropriate adjustments to statistical data.

0.2 Resources

0.2.1 Staff, facilities, computing resources, and financing

Formation of the index of the physical volume of market services

6 employees work in the Central Office, 3 employees in territorial statistics offices. The number of employees is sufficient to fulfill the tasks set for the formation of statistical data on statistics of the service sector.

All employees have higher education and at least 1 time in 2 years are trained at the courses of the Institute for Professional Skills Upgrading and Statistical Research under the State Committee of the Republic of Uzbekistan on Statistics.

Each workplace is provided with a personal computer connected to the local network.

The software is developed directly in State Committee on Statistics, which allows, if necessary, to make updates to it and changes in accordance with existing and emerging challenges.

The provided financial resources are sufficient to carry out the work stipulated by the Program of State Statistical Works on statistics of the service sector.

1. Integrity

1.1 Professionalism

1.1.1 Impartiality of statistics

State Committee of the Republic of Uzbekistan on Statistics

According to the Law “On Official Statistics (Article 6), the basic principles of state statistics are independence, transparency, accuracy, reliability, impartiality and objectivity, and statistical confidentiality.

1.1.2 Selection of sources, methodology, and modes of dissemination

State Committee of the Republic of Uzbekistan on Statistics

According to the Law “On Official Statistics” (Article 27), individual data held by the producers of official statistics are used exclusively for statistical purposes to compile aggregate statistical data.

Individual data cannot be used by state bodies, citizens' self-government bodies and other organizations, including international ones, for the purposes of investigation, control, litigation, administrative decisions or for other purposes related to individuals and legal entities or households.

1.1.3 Commenting on erroneous interpretation and improper use of statistics

State Committee of the Republic of Uzbekistan on Statistics

The State Statistics Committee may comment on erroneous interpretation and misuse of statistical data on an ad hoc basis.

1.2 Transparency

1.2.1 Disclosure of terms and conditions for statistical collection, processing, and dissemination

State Committee of the Republic of Uzbekistan on Statistics

According to the Law "On Official Statistics" (Article 6), the main principles of state statistics are independence, transparency and accessibility.

... The conditions for the collection, processing and dissemination of statistical data are included in the laws and regulations of the Republic of Uzbekistan concerning statistics. These legislative measures are posted on websites and are thus available to the public. Thus, the Law "On Official Statistics" (2021) is posted on the website of the Committee (www.stat.uz). The law is also reproduced in the bulletin of the Oliy Majlis (parliament) and included in the database on regulatory legal acts (norm), as well as in the database of the Ministry of Justice, available at www.Lex.uz.

1.2.2 Internal governmental access to statistics prior to release

The State Committee of the Republic of Uzbekistan on Statistics

The government does not have access to The State Statistics Committee data prior to their release. State statistical bodies are independent in the dissemination of statistical data. Intervention by state bodies is not allowed (Article 35 of the Law). Only the Chairman of the Committee has access to statistics prior to their publication.

1.2.3 Attribution of statistical products

The State Committee of the Republic of Uzbekistan on Statistics

Data published to the public is clearly identified by the data production agency (logo and footnotes).

1.2.4 Advance notice of major changes in methodology, source data, and statistical techniques

The State Committee of the Republic of Uzbekistan on Statistics

Before moving on to the new methodology, The State Statistics Committee provides the public with advance notice when major changes are made to methodology and statistical methods. The

State Statistics Committee posts on its website a relevant methodological note explaining what changes users should expect.

1.3. Ethical standards

1.3.1 Guideline for staff behavior

The State Committee of the Republic of Uzbekistan on Statistics

The State Committee on Statistics employees must follow the code of ethics, including the oath of secrecy, and not disclose any information provided to them in the performance of their duties. They are informed of the responsibilities at the time of appointment. Each employee of The State Statistics Committee is obliged to sign an agreement that obliges him not to disclose such data.

2. Methodology

2.1 Concepts and definitions

2.1.1 Concepts and definitions

The methodological basis for calculating the index of the physical volume of market services - "Methodological provisions for the statistical accounting of services produced (provided), including services provided in rural areas", approved by the Resolution of the State Statistics Committee of the Republic of Uzbekistan dated July 7, 2021 No. 17.

The calculation of the index of the physical volume of market services is carried out by the deflation method, based on the use of data on the dynamics of the production of market services, followed by a step-by-step aggregation of individual indices into consolidated by types of economic activities.

The index of the physical volume of market services is a weighted value that reflects the change in the volume of services over a certain period of time.

The volume of services in comparable prices is used as weights for aggregation. by type of economic activity of the current year.

2.2 Scope

2.2.1 Scope

2.2.1.1 Scope of the data

Geographic coverage of the data includes the Republic of Karakalpakstan, 12 regions and the city of Tashkent, as well as cities and districts.

The total volume of market services rendered for calculating the index of the physical volume of market services is formed on the basis of state statistical reporting and an assessment of the activities of individual entrepreneurs providing services:

- large enterprises;
- small enterprises and microfirms;
- non-profit organizations;

- farms;
- a sample survey of individual entrepreneurs and self-employed persons providing services.

2.2.1.2 Exceptions to coverage

There are no exceptions.

2.2.1.3 Unrecorded activity

The shadow economy is not taken into account.

2.3 Classification/sectorization

2.3.1 Classification/sectorization

Breakdown by types of services in accordance with the Statistical Classifier of Products (Goods, Works, Services) by types of economic activities of the Republic of Uzbekistan (hereinafter referred to as the SCP), in terms of services (section G-S), as well as by regions of the Republic of Uzbekistan.

The main unit of account is an institutional unit.

2.4 Basis for recording

2.4.1 Valuation

The volume of services in comparable prices by type of economic activity is used as weights for aggregation.

2.4.2 Recording basis

For legal entities, data is generated on an accrual basis.

2.4.3 Grossing/netting procedures

The indicator "index of the physical volume of market services" is calculated on a discrete basis on a quarterly (estimate), monthly (estimate) and annually (revised) on an accrual basis.

3. Accuracy and reliability

3.1 Source data

3.1.1 Source data collection programs

The basis for conducting statistical surveys of enterprises is a comprehensive and constantly updated Unified State Register of Enterprises and Organizations, functioning in accordance with the Resolution of the Cabinet of Ministers No. 274 dated September 25, 2012 "On approval of the provision on the Unified State Register of Enterprises and Organizations"

Data on the volume of market services rendered for calculating the index of the physical volume

of market services are formed according to the primary statistical data of the state statistical reporting, as well as on the basis of a sample survey.

3.1.2 Source data definitions, scope, sectorization, classifications, valuation, and time of recording

The index of the physical volume of market services is a weighted value that reflects the change in the volume of services over a certain period of time. The volume of services in comparable prices by type of economic activity is used as weights for aggregation.

Statistical coverage - the volume of market services by type of economic activity on a monthly basis for large enterprises, annually with the revision of data on annual reporting; quarterly assessment of small enterprises and microfirms, farms, non-profit organizations, annually with the updating of data on annual reports; the volume of services rendered by individual entrepreneurs and self-employed persons based on the results of quarterly sample surveys.

The volume of market services is formed for all types of economic activities, in terms of services (section G-S) in accordance with the Classifier of Economic Activities of the Republic of Uzbekistan (OKED rev. 2).

Statistical accounting of services produced (provided) by type of economic activity is carried out on an accrued basis in prices at the time of the provision of services (at current prices).

The volume index of market services is calculated using the deflation method using data from the baseline and current periods, followed by a step-by-step aggregation of individual indices into aggregated ones by type of economic activity.

The indicator is formed on the basis of statistical reporting.

Statistical coverage - the geographical coverage of the data includes the Republic of Karakalpakstan, 12 regions and the city of Tashkent, as well as cities and districts.

Data publication period: monthly - 20 working days after the reporting period, annually - no more than 5 months after the reporting period.

3.1.3 Source data timeliness

The data collection program is regulated by the State Statistical Works Program.

The information is formed by the State Statistics Committee of the Republic of Uzbekistan on a monthly basis - on the 20th day after the reporting period, annually - no more than 5 months after the reporting period.

3.2 Assessment of source data

3.2.1 Source data assessment

The data obtained are analyzed, undergo mandatory control and verification not only at the level of regional departments, but also at the State Statistics Committee. If errors are detected, the information is necessarily clarified again with the respondents.

Source data are analyzed for comparability with other related data sources.

3.3 Statistical techniques

3.3.1 Source data statistical techniques

To calculate the index of the physical volume of services, the volume of services of the reporting and base periods in comparable prices, a step-by-step aggregation of individual indices into aggregated ones by type of economic activity is used.

3.3.2 Other statistical procedures

The calculations use data from tax authorities, data from a sample survey of individual entrepreneurs and self-employed persons providing services.

3.4 Data validation

3.4.1 Validation of intermediate results

To calculate the indicator, a comparison is made of information for the base and current periods.

3.4.2 Assessment of intermediate data

An analysis of possible discrepancies in the main intermediate data is carried out, and the data is adjusted to eliminate discrepancies.

3.4.3 Assessment of discrepancies and other problems in statistical outputs

In case of discrepancies in the previously published data, changes are made during subsequent publications.

3.5 Revision studies

3.5.1 Revision studies and analyses

In case of discrepancies in the previously published data, changes are made during subsequent publications.

4. Practical suitability

4.1 Periodicity and timeliness

4.1.1 Periodicity

The calculation of the index of the physical volume of market services on a discrete basis is carried out on a quarterly basis, with a cumulative total - monthly, revised indicators - according to annual reports.

4.1.2 Timeliness

Data publication: annually - no more than 5 months after the reporting period.

4.2 Comparability

4.2.1 Internal comparability

After confirmation and dissemination, statistical series are not revised.

4.2.2 Time comparability

Data from 2010 are presented on the website of the State Statistics Committee of the Republic of Uzbekistan (<http://stat.uz>)

4.2.3 Comparability between sectors or areas

Information is received by The State Statistics Committee from the territorial departments of statistics.

4.3 Data revision

4.3.1 Data revision schedule

The data for the formation of the indicator are specified within the time frame provided for by the Program of State Statistical Works.

4.3.2 Designation of preliminary and / or revised data as such

Final data disseminated

4.3.3 Dissemination of the results of the study and analysis of data revisions

In case of clarification of previously published data, the revised data are provided in subsequent publications. Revised (final) data are disseminated through publications of The State Statistics Committee

5. Accessibility

5.1 Data

5.1.1 Form of presentation of statistical data

Disseminated data on the index of the physical volume of market services for the period from the beginning of the year.

The volume index of market services is calculated as a whole by services and by types of activities related to sections G - S.

In statistical publications, information on the index of the physical volume of market services is

presented in the form of a bulletin "Production of services by type of economic activity", tables and graphs.

5.1.2 Means and form of data dissemination

5.1.2.1 In print form - New issues

“Regional Yearbook of Uzbekistan”, “Uzbekistan in Figures”, “Social Development and Living Standards in Uzbekistan”.

5.1.2.2 Hard copy - Monthly bulletin

In statistical publications, information on the index of the physical volume of market services is presented in the form of a bulletin "Production of services by type of economic activity", tables and graphs.

5.1.2.3 Hard copy - Quarterly bulletin

5.1.2.4 Hard copy - Annually bulletin

In statistical publications, information on the index of the physical volume of market services is presented in the form of a bulletin "Production of services by type of economic activity", tables and graphs.

In statistical publications, information is presented in the form of press releases, tables and graphs.

Tables for special user requests.
