General information about enterprises and organizations excluding farms and dehkans, as of November 1, units.

In recent years, the State has been carrying out large-scale work to create decent living conditions for the population, improve the business environment, provide employment by supporting the country's socio-economic development, active entrepreneurship, innovative ideas and creative potentials.

In particular, small business and private entrepreneurship are considered the main link of our country's economy, and today large-scale work is being carried out to rapidly develop this sphere, support the activities of entrepreneurs, further expand their ranks and encourage them.

In particular, **as of November 1, 2023**, the number of enterprises and organizations operating in the republic (without dekhkan farms and farms) amounted to **490.4** thousand units, of which **422.6** thousand units were small enterprises and micro-firms.

Also during this period, **682.1** thousand units of enterprises and organizations were registered, and the growth rate, compared to the same period of the last year, amounted to **110.1 %**.

Today, as a result of reforms aimed at removing obstacles to the development of private property, the small business and entrepreneurship sector has become a real pillar of the national economy.

In particular, **as of January 1, 2023**, the total number of business entities operating in the Republic (excluding farms and dehkan farms) amounted to **527.2** thousand, of which 238.6 thousand have been operating for three years, **118.8** thousand for five years, **86.7** thousand for ten years, **83.0** thousand for more than ten years.

By region, the largest share of active business entities operating for more than ten years (compared to the total number) falls on Syrdarya (**18.2 %**), Andijan (**18.0 %**), Fergana (**17.4%**), Kashkadarya (**17.1 %**) regions and Tashkent city (**17.4 %**).




In **January-October** of this year, the number of newly created enterprises and organizations in the Republic amounted to **76.7 thousand**.

In the regional context, a significant increase in the number of newly created enterprises and organizations, compared with the corresponding period last year, is observed in the Republic of Karakalpakstan (by **1 784** units), Bukhara region (by **1 162** units) and Tashkent city (by **1 106** units). In the context of industries, the highest level was demonstrated by the transportation and storage industries - by **671** units and information and communications - by **352** units.


As of November 1, 2023, the number of operating enterprises and organizations amounted to 490.4 thousand. If compared with the same period in 2019, the growth rate was 125.4 %.

A significant share of enterprises in the distribution by type of economic activity (share in the total number) falls on the trade sector – 32.6 %, industry – 14.5 %, agriculture, forestry and fisheries – 8.0 %, construction – 7.2 %, and in the regional context – Tashkent city – 20.0 %, Tashkent – 9.3 %, Samarkand – 9.0 %, Fergana – 8.8 % and Kashkadarya – 7.0% of the region.




As of November 1, 2023, the number of active business entities reached 426.3 thousand. If compared with the same period in 2019, the growth rate was 129.1 %.

Their distribution by type of economic activity (share in the total number) was as follows: trade – 37.5 %, industry – 16.6 %, agriculture, forestry and fisheries – 9.1 %, construction – 8.2 %, accommodation and catering services – 6.7 %, transportation and storage – 4.2 %, information and communications – 2.4 %, healthcare and social services – 2.2 %, other types – 13.1 %.




An important factor for assessing the "health" of the country's economy is the effective functioning of small businesses, which is an indicator of flexibility, the ability to adapt to the constantly changing economic situation.

Thus, in **January-October 2023**, the number of newly created small business entities in relation to the corresponding period of **2022** increased in the transportation and storage industry – from **2 785** to **3 456** units (an increase of **671** units), information and communications – from **2 156** to **2 515** units (an increase of **359** units).



By type of economic activity



The industrial sector has the greatest potential among other sectors of the economy.




In Uzbekistan, the construction industry is defined as a priority sector of the economy.

The analysis carried out by sections in the construction industry showed that:

- the number of enterprises in the construction of buildings and structures section has reached **54.1 %**;
- the number of enterprises in the specialized construction works section amounted to **30.4 %**.
- the number of enterprises in the construction of civil facilities section is fixed at the level of **15.5 %**;

The distribution by sections in the trade industry is as follows:


- retail trade, except for the sale of cars and motorcycles, reached **60.6 %**;







The number of enterprises involved in the creation of programs, broadcasting and communications in the information and communications industry amounted to **25.1 %**.



A significant part of the total number of enterprises and organizations operating in the field of healthcare and social services – **9 521** units or **86.8 %** - is accounted for by business entities.







As of November 1, 2023, the number of operating enterprises and organizations in the transportation and storage industry amounted to **3.7 %** of the total number of enterprises in the country.

formation of information resources of registers, registers and cadastres containing information about economic entities;





Quantity, by year








A limited liability company is a company established by one or several persons, the authorized fund (authorized capital) of which is divided into the sizes of shares determined by the constituent documents. Participants of a limited liability company shall not be liable for its obligations and shall bear the risk of losses related to the activities of the company within the value of their contributions.


Also, participants of a limited liability company who have not made contributions in full are jointly and severally liable for their obligations to the extent of the value of the unpaid part of each participant's contribution.

Quantity, by year








Out of 426.3 thousand operating commercial enterprises and organizations, as of November 1, 2023, limited liability companies account for 308.2 thousand and occupy the first place among enterprises in organizational and legal form. Based on this, it can be concluded that these societies are the most common form of entrepreneurial activity in the country.






A private enterprise is a commercial organization created and managed by an owner - an individual, representing the organizational and legal form of business entities.

This organization owns separate property, can acquire and exercise property and personal non-property rights on its own behalf, bear obligations, act as a plaintiff and defendant in court.




Quantity, by year




As of November 1, 2023, when comparing the number of operating enterprises by their organizational and legal form, private enterprises took second place after limited liability companies. The highest figures were recorded in Tashkent city – 8 268 units, Fergana – 8 221 units and Kashkadarya – 8 190 units. By types of economic activity, private enterprises were distributed in the trade sector – 29 415 units, industry – 10 391 units, accommodation and catering – 5 418 units and construction – 4 359 units.







The activity of a family enterprise, which is one of the organizational and legal forms of business entities, is based on the personal labor of its participants.







Catching fish and representatives of aquaculture are the main activities of the fishing section, the share of the number of enterprises is **3.1 %** of the total number of enterprises in this industry.

Enterprises with the participation of foreign investment are enterprises in the authorized capital of which non-residents, foreign legal entities (branches and departments of foreign companies), foreign citizens and stateless persons participate.


We see that as a result of intensive work on the development of international economic cooperation in our country, the number of enterprises with foreign investment is increasing significantly.

In **January-October 2023**, the number of newly created enterprises and organizations with the participation of foreign capital increased by **106.5 %** compared to the corresponding period in **2021**.

Over the past five years, the number of operating enterprises with foreign investments has increased by 1.3 times.

The leading place is occupied by the Russian Federation – 2 854 enterprises with full or partial participation, which is 21.9 % of the total number of operating enterprises with foreign investments in the republic. Among the countries pouring their capital into the economy of Uzbekistan, China (15.6 % of the total number of operating enterprises with foreign investments in the republic), Turkey (13.6 %), Kazakhstan (7.4 %) and South Korea (5.4 %) also occupy a special place.

Uzbekistan is carrying out comprehensive economic and social reforms aimed at accelerating economic growth, expanding international relations and creating favorable legal conditions for foreign direct investment. The country's strategic geographic location, rich and diverse natural resources represent a huge potential for investment and growth. The government of the republic pays close attention to increasing foreign investment in order to stimulate business development and the introduction of modern technologies to improve the well-being of its citizens.

The main features of the new foreign policy of Uzbekistan are openness, attention to the priorities of long-term sustainable development, strengthening good neighborly relations with neighboring countries, expanding international cooperation on an impartial basis.

As a result, it is noted that today consistent reforms are being carried out in various sectors of the economy of Uzbekistan aimed at stimulating the process of creating the internal conditions necessary for doing business and attracting investments.

Based on this, out of **13 019** units. operating enterprises with foreign investment **4 822** units. are joint, and **8 197** units. come from foreign enterprises.

In order to create the most favorable investment climate in the country for attracting direct investment, large-scale measures have been taken to liberalize the economy, limit interference in the activities of business entities, reduce and simplify licensing and permit procedures, ensure free access to goods (works and services), as well as create in the regions of necessary infrastructure. As a result, every year there is an increase in enterprises with foreign investment.

So, **as of November 1, 2023**, the number of registered enterprises with foreign investments increased by **2 334** units. compared to the same period last year and reached **17 958** units.

In recent years, Uzbekistan has gone through an accelerated transformation of the economy and is increasingly featured in the international community as one of the symbols of openness, innovation and determination in removing various barriers to business and investment.

Thus, the increase in the number of enterprises with foreign investments is primarily due to political stability and the improvement of the legal framework for investment activities in the country.

Small business entities are extremely important for the market economy, as they act as a driver of sustainable economic growth of the country. The production of new goods and services contributes to the creation of new jobs, which ultimately leads to accelerated economic development. In addition, the main priorities should be the introduction of free market mechanisms, ensuring healthy competition and immunity of private property, as well as support for small businesses.

A significant increase in business entities was expressed by an increase in the number of operating small businesses from 189.9 thousand on **January 1, 2014** to **523.6 thousand on January 1, 2023**.

The rapid development of the national economy and ensuring high growth rates are one of the most important priorities of the development strategy of New Uzbekistan for **2022-2026**.

The Unified State Register of Enterprises and Organizations – is an automated information and reference system consisting of information that is updated in real time and provides state accounting and identification of enterprises and organizations based on a unified system of classifications.

Registered – legal entities that have passed state registration with the registration authority in the prescribed manner and have legal entities in the State Register (with the exception of liquidated legal entities).

Active – legal entities that have passed state registration with the registration authority in the prescribed manner, and have not provided information on the non-execution or completion of financial and economic activities.

Newly created – legal entities that have passed state registration with the registration authority in the prescribed manner and are entered (newly included) in the state register of legal entities.

The level of activity of legal entities - according to the Decree of the President of the Republic of Uzbekistan No. **PD-5739 of June 7, 2019** and the Resolution of the Cabinet of Ministers of **August 21, 2019 No. 704**:

- banks must notify the state tax authorities through the system about the non-receipt of funds to the accounts of commercial enterprises within 9 months;

- after that, based on the submission of the state tax authorities, the Public Service Centers will transfer the enterprise to a state of inactivity, about which a corresponding entry will be made in the state register and the System.

Small enterprises and micro-firms are organizations related to small businesses in accordance with Appendix 1 to the Resolution of the Cabinet of Ministers of the Republic of Uzbekistan dated **August 24, 2016 No. 275** "On measures to transfer to the international system of classification of types of economic activity".

Enterprises with the participation of foreign investment – enterprises with the participation of non-residents, foreign legal entities (branches and divisions of foreign firms), foreign citizens and stateless persons in the authorized capital of the enterprise.
