
## RETAIL AND WHOLESALE TRADE TURNOVER OF THE REPUBLIC OF UZBEKISTAN


**Statistical data** - is the most important tool for describing and managing socio-economic phenomena and processes occurring in society. At present, it is impossible to make informed management decisions in the sphere of public policy without using high-quality statistical data. Among them, the formation of trade statistics is of great importance. In particular, this includes the indicator of statistics of the turnover of wholesale, retail and catering enterprises.



As of December 1, 2024, the number of commercial enterprises operating in the retail trade sector reached 89 235 units, of which the number of operating large enterprises amounted to 319 units, and small enterprises and micro firms - 88 916. In particular, the retail trade indicators include data collected on the basis of observations of organized and unorganized trade among individuals operating in the trade sector without forming a legal entity.

**Retail turnover** is the cost of goods sold to the population for personal, family, household and other similar use not related to entrepreneurial activity.

## Dynamics of growth rates and turnover in retail trade (for January-November, in billion soums)



Over the past five years (2020–2024), high growth rates in retail turnover were recorded in 2022, and this figure amounted to 111.9 %.

## Retail growth rates by month (for 2023-2024, in %)



In January-November 2024, the growth rate of retail turnover was 109.7 %.

Retail trade turnover for January-November 2024 reached 334 460.2 billion soums and increased by 109.7 % compared to the same period in 2023. Also, the turnover of large enterprises amounted to 57 311.3 billion soums (growth rate - 108.7 %), and small businesses and private entrepreneurship – 277 149.0 billion soums (growth rate - 109.9 %), including unorganized trade amounted to 33 051.4 billion soums (growth rate - 113.8 %).



Compared with January-November 2023, significant growth rates in the period under review were noted in the Tashkent region (111.5 %), Tashkent city (110.8 %) and Namangan region (109.9 %), where an increase in the growth rate of retail trade was observed.

(for January-November 2024, in %)




In the structure of retail trade turnover, a significant share in January-November 2024 was noted in Tashkent city, which amounted to 25.6 %, or 85 628.4 billion soums.

The smallest share was recorded at 1.6 %, or 5 426.1 billion soums, which was observed in the Syrdarya region.

Compared with the corresponding period of 2023, during the period under review, an increase in growth rates in retail trade was noted in all regions.

## Regions with the highest growth rates of small business and private entrepreneurship

The retail trade turnover of small businesses and private entrepreneurship, according to statistical calculations, in January-November 2024 amounted to 277 149.0 billion soums and, compared to the same period in 2023, increased by 9.9 %. The share of this sector in the republic in the retail trade turnover reached 82.9 %.


## Regions with the highest growth rates of large enterprises

In the structure of retail trade turnover, the volume of trade turnover of large enterprises in January-November 2024, compared with the corresponding period of 2023, increased by 8.7 % and reached 57 311.3 billion soums, which amounted to 17.1 % of its total volume..




The share of small businesses and private entrepreneurship, compared to other regions, in January-November 2024 was the highest in the Republic of Karakalpakstan (97.1 %), Surkhandarya (96.5 %) and Khorezm (96.5 %) regions. In the structure of retail trade turnover, the share of large enterprises' turnover amounted to 17.1 % of total sales, their main share was observed in Tashkent city (41.9 %), Tashkent (15.9 %), Samarkand (12.9 %) and Fergana (10.5 %) regions.




## VOLUME PER CAPITA IN RETAIL TRADE TURNOVER

(information by region, in thousands of soums)




Retail trade turnover per capita in the republic for January-November 2024 averaged 9 020.5 thousand soums (compared to the same period in 2023, it increased by 107.4 %). The highest volume, compared to other regions, was recorded in Tashkent city (27 909.3 thousand soums), Navoi (11 725.8 thousand soums) and Tashkent (10 207.9 thousand soums) regions.



**Unorganized trade turnover** is also taken into account when forming indicators of domestic trade. This includes the volume of sales made by individuals at the dehkan (food) market, as well as at the livestock, poultry and other animal markets. Unorganized trade includes agricultural products grown by individuals (farmers) on their own farms.


**A dehkan (food) market** is a property complex operating on a permanent or temporary basis in places intended to create the necessary conditions for the retail sale and purchase of a wide range of agricultural food products and processed products using shopping arcades, trading places and stationary retail outlets (including retail pavilions).



## Volume of unorganized trade turnover by region (for January-November 2024, in billion soums)



According to preliminary data from the survey of individuals, the turnover of unorganized trade for January-November 2024 amounted to 33 051.4 billion soums and, compared to the same period in 2023, it increased by 113.8 %. Including the turnover of trade in dehkan markets amounted to 17 177.8 billion soums (an increase of 118.9 %), the turnover of trade in livestock markets was recorded at 15 873.6 billion soums (a decrease of 108.7 %).

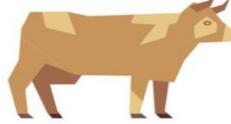
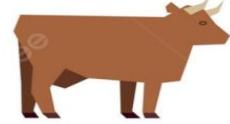
In January-November 2024, a survey of individuals engaged in the sale of agricultural products (grown in private farms) was conducted in all regions of the republic, according to the results of which the turnover of this type of trade amounted to 17 177.8 billion soums. High sales of fresh agricultural products reached 8 209.1 billion soums.

In January-November 2024, a survey of individuals engaged in the sale of poultry and livestock (kept in private farms) was conducted in all regions of the republic, according to the results of which the turnover of this type of trade amounted to 15873.6 billion soums. The sale of livestock of different ages reached 12510.3 billion soums, sheep and goats - 2583.6 billion soums, horses - 447.6 billion soums, birds - 63.5 billion soums.

## TURNOVER OF FOOD ENTERPRISES

As of December 1, 2024, the number of commercial enterprises operating in the public catering sector amounted to 25 571 units, of which the number of large operating enterprises amounted to 80 units, and the number of small enterprises and micro firms reached 25 491.


In January-November 2024, the turnover of public catering enterprises amounted to 157 307.1 billion soums and increased by 113.1 % compared to the same period in 2023, of which 86.0 % of the trade turnover is accounted for by small businesses.


The highest volumes, compared to other regions, were recorded in Tashkent city (54 438.7 billion soums), Jizzakh (12 391.1 billion soums) and Fergana (6 153.6 billion soums) regions.

## Turnover of wholesale and retail trade in motor vehicles and their accessories (in billion soums)




The turnover of wholesale and retail trade in motor vehicles and their accessories (except for maintenance and repair of motor vehicles) for January-November 2024 amounted to 113 594.0 billion soums and increased by 23.6 % compared to the same period in 2023. The turnover of large enterprises amounted to 46 981.3 billion soums (growth rate - 147.1 %), and small businesses and private entrepreneurship – 66 612.7 billion soums (growth rate - 111.1 %).

## Growth rates of wholesale and retail trade in motor vehicles and their accessories



**Wholesale turnover** is the cost of goods purchased from outside for the purpose of resale and actually shipped without modification to third-party organizations and individual entrepreneurs for use in business activities or for their own use (processing), regardless of whether payment has been made for these goods or not.

## Wholesale turnover in the republic (in billion soums)



According to preliminary data, in January-November 2024, the volume of wholesale trade turnover reached 368 548.3 billion soums and, compared to the same period in 2023, increased by 11.1 %.

## Share and volume of trade turnover



The turnover of wholesale trade of small business entities, according to statistical calculations, amounted to 271 008.2 billion soums and, compared to the corresponding period of 2023, increased by 110.5 %. The share of this sector in the turnover of wholesale trade in the republic amounted to 73.5 %.

As of December 1, 2024, the number of commercial enterprises operating in the wholesale trade sector amounted to 48 957 units, of which the number of large operating enterprises is 339, small enterprises and micro firms – 48 618.

In January-November 2024, the highest growth rates of wholesale turnover of large enterprises, compared to the same period in 2023, were observed in the Republic of Karakalpakstan (179.9 %), Samarkand (147.1 %) and Tashkent (137.5 %) regions.
