

Dynamics of gross domestic product (GDP) of the Republic of Uzbekistan¹, January-June



In accordance with the preliminary assessment, in January-June 2024, the GDP of the Republic of Uzbekistan in current prices amounted to 567 364.3 billion soums and, compared to January-June 2023, increased in real terms by 6.4 %. The GDP deflator index, in relation to prices in January-June 2023, amounted to 112.5 %.

The physical volume index (real growth rate) of GDP is calculated as the ratio of the GDP of the reporting period, calculated in constant prices, i.e. in prices of the corresponding period of last year (real GDP) to GDP in current prices of the corresponding period of last year.


Gross domestic product (GDP) is one of the most important indicators of the System of National Accounts (SNA), characterizing the final result of the production activities of resident economic units, which is measured by the cost of goods and services produced by these units for final use.


**Dynamics of GDP of the Republic of Uzbekistan,

Production of goods




Services sector

**Dynamics of GDP of the Republic of Uzbekistan,
January-June, billion US dollars**



For information : in January-June 2024, the official exchange rate of the US dollar against the soum averaged **12 567.0** soum, in January-June 2023 – **11 388.7** soum, in January-June 2022 – **11 046.9** soum, in January-June 2022 – **11 046.9** soum, in January-June 2021 – **10 524.5** soums, January-June 2020 – **9 790.2** soums.

When calculated in US dollars at the average exchange rate for the reporting period, nominal GDP amounted to **45 147.2** million US dollars.

In January-June 2024, a positive contribution to GDP growth was made by agriculture, forestry and fisheries - **0.7** percentage points, industry - **2.0** percentage points, construction - **0.6** percentage points and service sector – **2.8** p.p. Due to the increase in net taxes on products, GDP increased by **0.3** percentage points.


Dynamics of the contribution of industries to GDP growth, January-June, in % to total



Gross added value created by all sectors of the economy amounted to **95.8** % of total GDP and increased by **6.5** % (contribution to GDP growth - **6.1** percentage points). Net taxes on products in the structure of GDP amounted to **4.2** % and, compared to January-June 2023, they increased by **4.8** % (contribution to GDP growth - **0.3** percentage points).

Based on the results of January-June 2024, minor changes were noted in the sectoral structure of GDP. Thus, the share of the service sector in the sectoral structure of GDP (GVA) increased from **47.0** % to **47.9** %, industry - from **26.5** % to **27.8** %, while the share of agriculture, forestry and fisheries decreased from **20.1** % to **18.2** %, construction - from **6.4** % to **6.1** %.

Structure of GDP by type of economic activity, January-June, in % to total






GDP per capita, January-June, at current prices, thousand soums



For reference: the average permanent population of the Republic of Uzbekistan was: in January-June 2020 - 34 049.6 thousand people, January-June 2021 - 34 709.5 thousand people, January-June 2022 - 35 437.4 thousand people, January-June 2023 - 36 198.7 thousand people, January-June 2024 - 36 967.0 thousand people.

In January-June 2024, GDP per capita in current prices amounted to **15 347.9** thousand soums (or, equivalently, **1 221.3** US dollars).


Growth (decrease) rate of GDP per capita, January-June, in % to the corresponding period last year



As is clear from the presented infographics, in January-June 2024, GDP per capita growth in real terms, compared to January-June 2023, amounted to **4.2 %**, and, compared to January-June 2020, - **17.0 %**.

GDP (GRP) per capita is determined by dividing the total GDP (GRP) at current prices by the average population of the country (region) for a certain period of time.

Gross value added of agriculture, forestry and fisheries, January-June




Based on the results of January-June 2024, **agriculture, forestry and fisheries** showed a positive growth rate of **3.8 %** (in January-June 2023 - **3.7 %**, January-June 2022 - **2.6 %**, January-June 2021 - **1.8 %**, January-June 2020 - **2.4 %**).


For information: in January-June 2024, the total volume of products (services) in agriculture, forestry and fisheries amounted to **170 297.3 billion soums**. Of their total volume, the share of crop and livestock farming, hunting and services provided in these areas accounts for **97.0%**, forestry - **2.4%**, and fisheries - **0.6%**.

Based on the results of January-June 2024, the positive growth dynamics in this industry is due to an increase in crop production and livestock farming, hunting and services provided in these areas by **3.8%**, forestry by **2.8%** and fisheries by **4.6%**.

Volume, billion soums




Growth rate, in % compared to the corresponding period last year

Based on the results of January-June 2024, in the field of **industry** saw an increase in added value by **7.8 %**.

The positive dynamics in this industry is mainly due to the growth in added value of the mining and quarrying industry by **0.5 %**, the manufacturing industry by **9.4 %**, electricity supply, gas, steam and air conditioning by **4.3 %** and water supply and sewerage, waste collection and disposal – by **0.3 %**.


Gross added value of industry,

January-June




Structure of gross added value of industry,

Gross added value of construction, January-June




Compared to January-June 2023, **construction works** in January-June 2024 increased by **10.1** %. At the same time, the growth rate of construction of buildings and structures amounted to **111.9** %, civil facilities - **110.9** %.

For specialized construction work, there was a decrease in volume in comparable prices, which amounted to **98.8** % compared to the level of January-June 2023.


For information: in January-June 2024, the volume of construction work amounted to **79 833.9** billion soums. Of their total volume, to share of large organizations account for **27.8** %, small enterprises and micro-firms – **56.1** %, individuals – **16.1** %.

January-June, billion soums**


Construction of buildings and structures




Construction of civil facilities




Specialized construction work

January-June, in % to total**




Gross value added of the service sector, January-June




At the end of January-June 2024, the gross added value of the service sector amounted to **260 182.6** billion soums and, compared to January-June 2023, increased by **6.4** %. Including trade services increased by **10.4** %, accommodation and food – by **9.6** %, transportation and storage – by **7.0** %, information and communications – by **19.7** %, other services – by **4.5** %.

Structure of gross value added in the service sector, January-June, in % to total




Gross value added of trade, January-June



In January-June 2024, in the structure of gross added value of **trade** the largest share fell on retail trade (except for trade in motor vehicles) and reached **61,4 %**. The share of wholesale trade (except for trade in motor vehicles) was **29,7 %**, wholesale and retail trade in motor vehicles and their repair – **8,9 %**.

Structure of gross value added of trade, January-June, in % to total




Gross added value of transportation and storage, January-June




Based on the results of January-June 2024, the share of **transportation and storage** in the GDP of the Republic of Uzbekistan amounted to **5.6 %**.

In the structure of gross added value of the transportation and storage industry, the largest share was accounted for by road transport - **49.3 %**. Pipeline transport accounted for **17.0 %**, railway transport – **10.2 %**, auxiliary transport activities – **15.3 %**, air transport – **8.2 %** of the total value added in this industry.

Structure of gross added value of transportation and storage, January-June, in % to total




Gross value added of information and communication, January-June



In January-June 2024, the share of **information and communications** in the country's economy was **2.6 %**. In the structure of added value of this industry, the main share fell on communication services (wired and mobile communication services, Internet, etc.) and amounted to **44.0 %**. The remaining **56.0 %** of the added value created in this industry comes from other spheres (publishing activities, computer programming activities, program creation activities and television and radio broadcasting, etc.).

Structure of gross value added of information and communication, January-June, in % to total




► PRODUCTION OF GROSS DOMESTIC PRODUCT

In January-June 2024, the share of **information and communication technology (ICT) services** in the country's economy was **2.4 %**.


The added value of ICT services consists of communication services - **47.7 %**, computer programming, consultations and other related services - **35.2 %**, data hosting and processing services, Web portals - **9.0 %**, software release - **4.9 %**, repair of computers and communication equipment - **3.2 %**.

Gross added value created in small enterprises (businesses) by type of economic activity for January-June 2024



Based on the results of January-June 2024, **small enterprises(businesses)** created added value in the amount of **257 993.6 billion soums**, or **47.5 %** of the total added value in the economy. At the same time, the share of agriculture, forestry and fisheries in the total GVA of small enterprises (businesses) was **37.1 %**, industry - **12.8 %**, construction - **9.6 %** and the service sector - **40.5 %**.

The share of small entrepreneurship (business) in the main sectors of the economy was: in agriculture, forestry and fisheries - **96.7%**, construction - **74.8%**, services - **40.1%** and industry - **21.9%**.
