### **I. Information on small business entities in the Republic of Uzbekistan**

As of January 1, 2026, the number of active small business entities is 1 201.6 thousand, of which the number of small enterprises and microfirms (including farms and dehqan farms) is 493.0 thousand, the number of individual entrepreneurs is 284.4 thousand, the number of dehqan farms is 395.6 thousand, family entrepreneurs - 5.6 thousand, craftsmen - 22.1 thousand, sellers of imported goods - 0.9 thousand.

As of January 1, 2026, the number of operating small business entities per 1 000 people was 31.7 units.

In terms of regions, the highest number of small business entities (per 1 000 people) was observed in the Jizzakh region - 61.0 units, Tashkent city - 45.3 units, Khorezm region - 44.8 units, and Syrdarya region - 37.5 units.

## **II. Newly created small enterprises and microfirms**

In January-December 2025, 82.4 thousand new small enterprises and microfirms were created (excluding dehkan and farming households).

In January-December 2025, by type of economic activity, the highest number of newly created small enterprises and microfirms was observed in trade – 30 205 units, industry – 10 490 units, agriculture, forestry and fisheries – 9 924 units, and in accommodation and food services – 7 262 units.

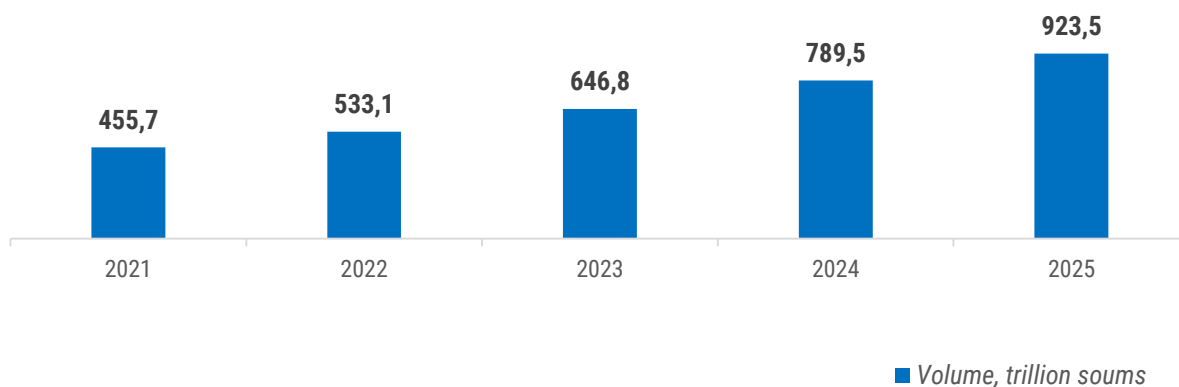

### III. Main economic indicators of small business entities

In January-December 2025, the volume of small business entities in the GDP structure amounted to 923 514.6 billion soums, and their share in the total GDP reached **52.2%**.

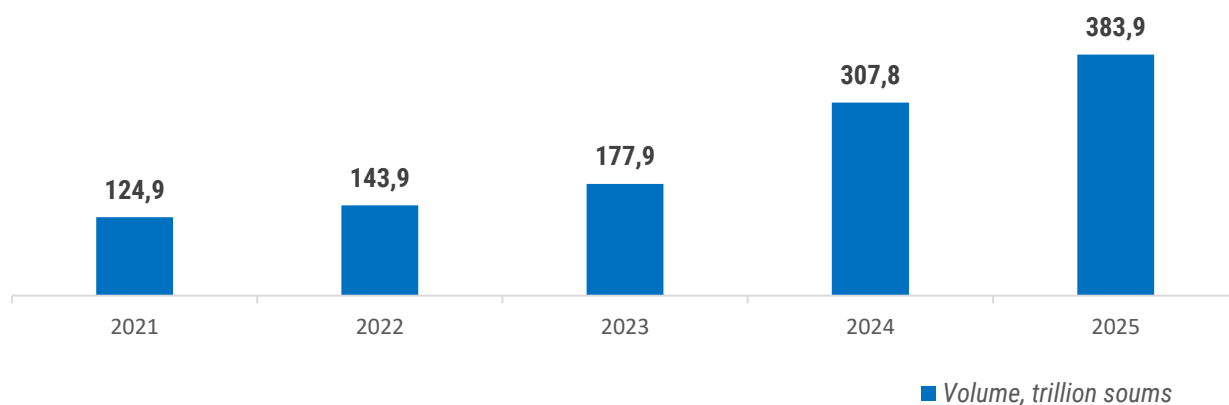
#### Volume of small business entities in GDP



By type of economic activity in January-December 2025, the largest share of small business in GDP was in agriculture, forestry, and fisheries - **93.1%**, construction - **75.6%**, services - **47.2%**, and industry - **28.5%**.

In January-December 2025, small business entities produced industrial products worth 383 886.1 billion soums, and their share in the total industrial production amounted to **34.9%**. The growth rate compared to the corresponding period of 2024 reached **114.8%**.

#### Dynamics of industrial production volume for small business entities



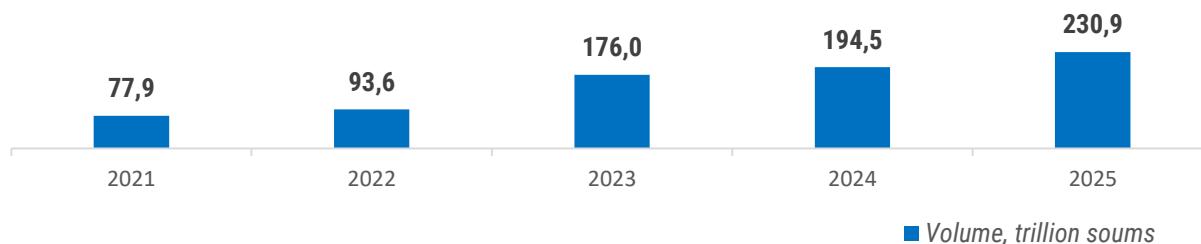

In January-December 2025, the volume of construction work performed by small business entities amounted to 230 926.9 billion soums, or **73.6%** of the total volume of construction work. The growth rate compared to the corresponding period of 2024 reached **112.2%**.

### Dynamics of changes in the volume of small business entities in construction



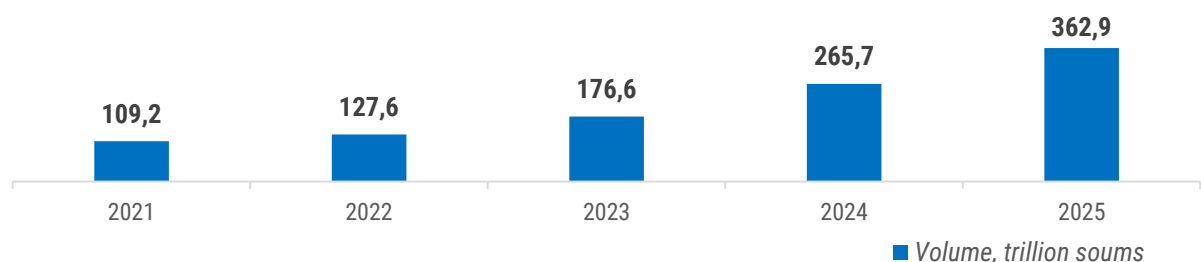

In January-December 2025, small business entities utilized 362,910.0 billion soums of investments in fixed assets, accounting for **61.4%** of the total volume. The growth rate compared to the corresponding period of 2024 reached **129.9%**.

### Dynamics of fixed capital investment volume for small business entities



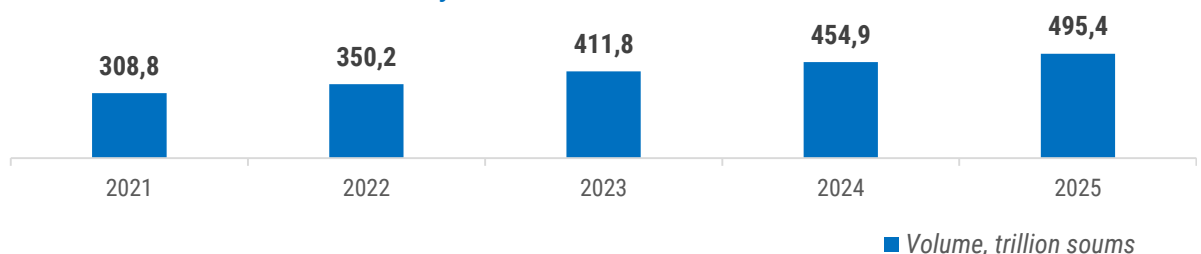

In January-December 2025, the volume of products (services) of agriculture, forestry and fisheries of small businesses amounted to 495,445.2 billion soums, or **91.9%** of the total volume. The growth rate reached **101.9%** by the corresponding period of 2024.

### Dynamics of agricultural, forestry and fishery production volume by small business entities



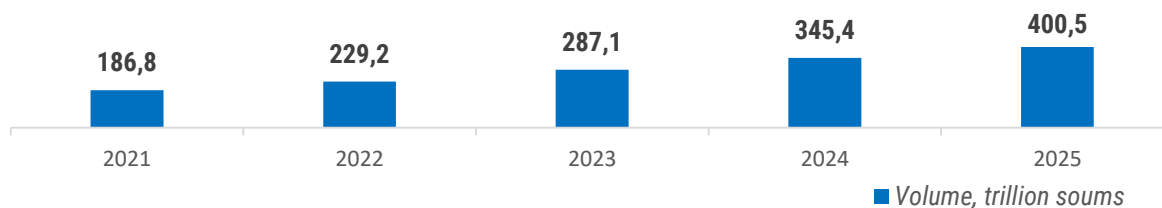

In January-December 2025, the retail trade turnover of small business entities amounted to 400 503.2 billion soums, or **83.0%** of the total volume. The growth rate compared to the corresponding period of 2024 reached **109.6%**.

### Dynamics of retail trade turnover of small business entities



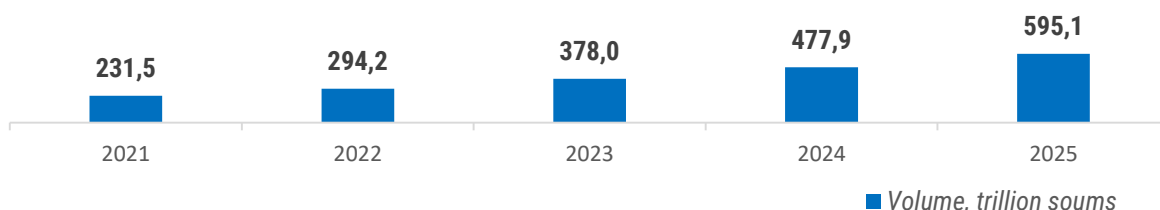

In January-December 2025, small businesses produced (rendered) services worth 595 090.5 billion soums (**56.7%** of the total volume). The growth rate compared to the corresponding period of 2024 reached **114.3%**.

### Dynamics of the volume of services provided by small business entities



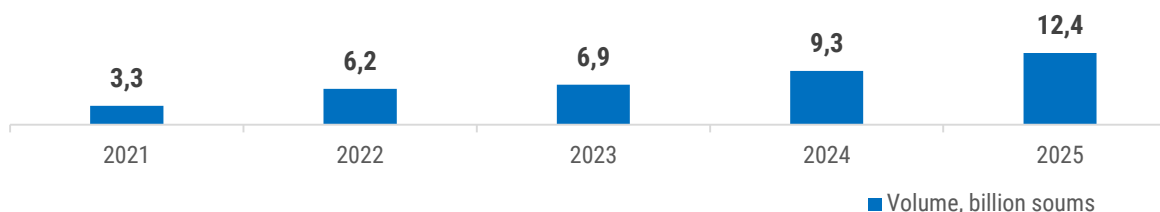

In January-December 2025, the export volume of products (goods, works, and services) by small businesses amounted to 12.4 billion US dollars, or **36.6%** of total exports.

### Dynamics of export volume of products (goods, works and services), carried out by small business entities



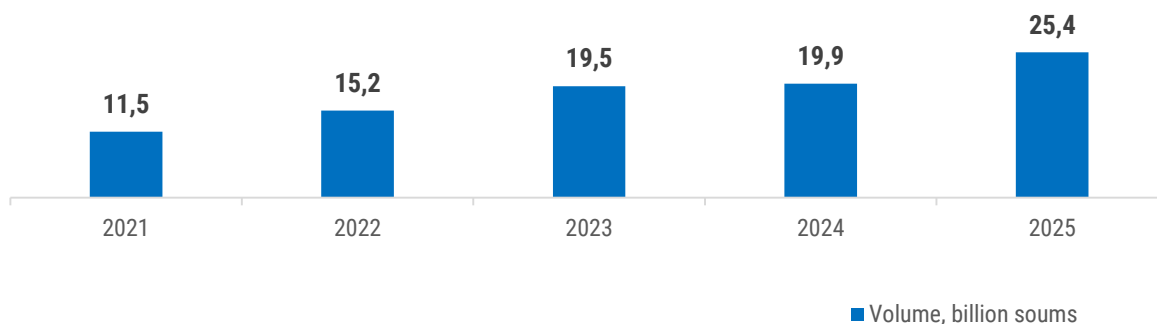

For January-December 2025, the import volume of products (goods, works and services) by small businesses amounted to 25 390.3 million US dollars, or **53.6%** of the total import volume.

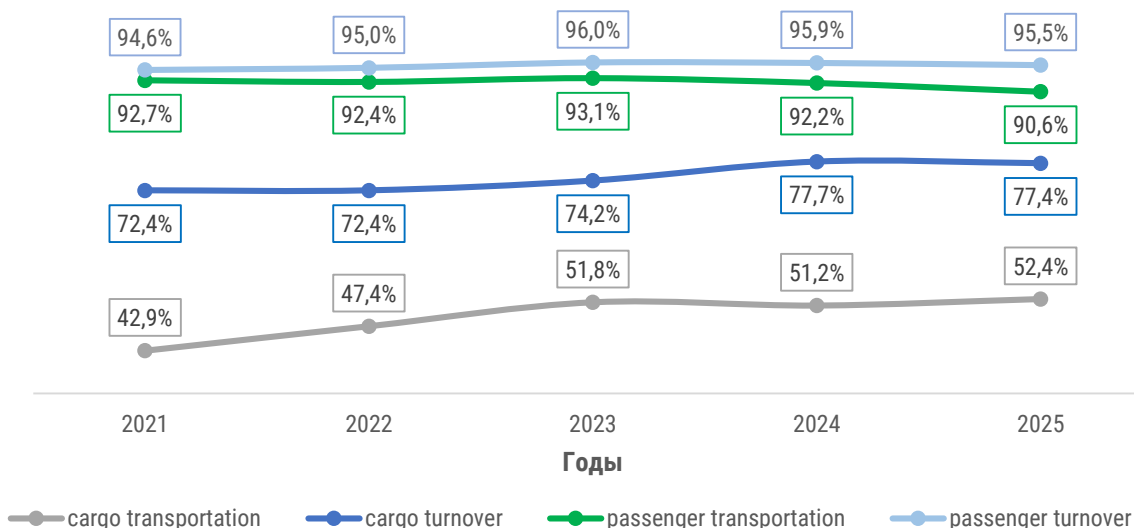

### IV. Main indicators of small business entities in the transport sector

For January-December 2025, the share of small business entities in the total volume of road freight transportation amounted to **52.4%**. The growth rate compared to the corresponding period of 2024 was **107.2%**.

In the period under review in 2025, the share of small businesses in the total volume of road freight turnover amounted to **77.4%**. The growth rate compared to the corresponding period of 2024 was **106.8%**.

In January-December 2025, the share of small businesses in the total volume of passenger transportation by road amounted to **90.6%**. The growth rate compared to the corresponding period of 2024 was **103.3%**.



In January-December 2025, the share of small business entities in the total volume of passenger turnover of road transport amounted to **95.5%**. The growth rate compared to the corresponding period of 2024 was **103.0%**.

## **V. Methodological explanations and metadata on statistics of small business entities**

The calculation of the share of small businesses by sector is carried out in accordance with the relevant methodological provisions of the sectoral departments.

According to the rules, the main indicators of small business development are available at current prices, taking into account the activities of individual entrepreneurs. Changes in volume compared to the same period of the previous year are calculated taking into account changes in the price index.
