

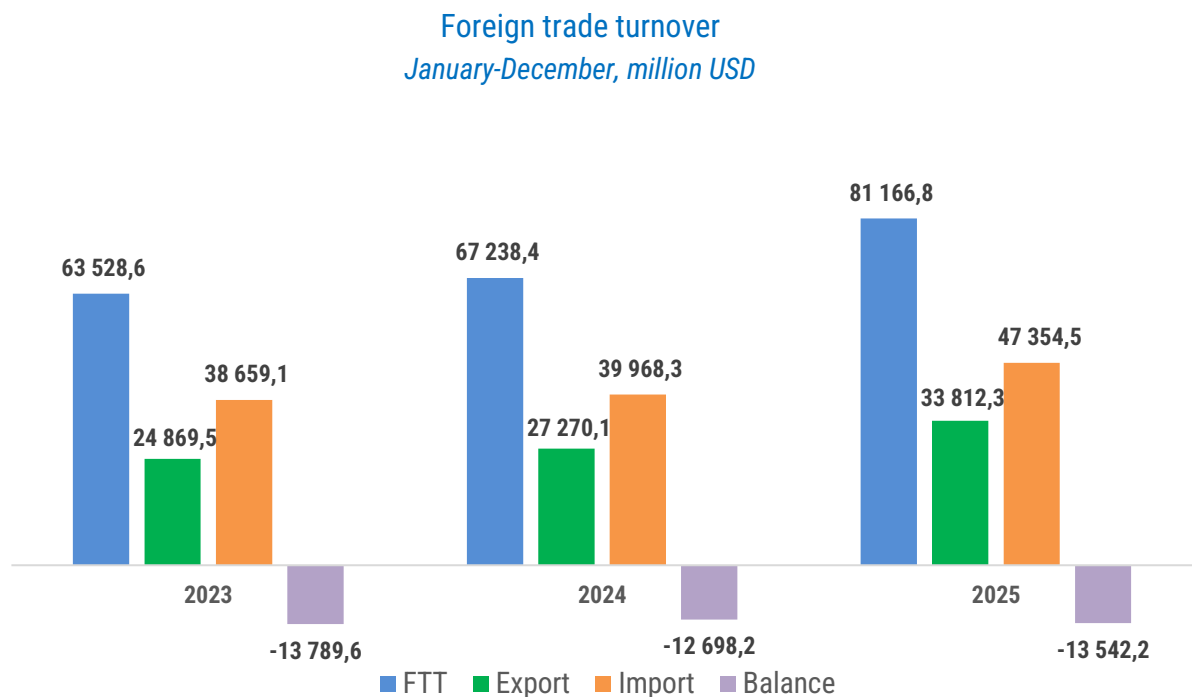

I. Foreign trade turnover

In January–December 2025, the foreign trade turnover (FTT) in the country amounted to 81.2 billion US dollars and increased by 13 928.4 million US dollars, or by 20.7%, compared to 2024.



Of the total FTT volume, exports amounted to 33 812.3 million USD (an increase of 24.0% by 2024), while imports reached 47 354.5 million USD (an increase of 18.5% by 2024). As a result, there was a negative balance of 13 542.2 million USD.

The Republic of Uzbekistan maintains trade relations with 210 countries worldwide. The largest volume of foreign trade turnover was recorded with China (21,2%), Russia (16,0%), Kazakhstan (6,1%), Türkiye (3,7%), and the Republic of Korea (2,1%).

In the export structure, goods account for 71,1%, including industrial goods – 11,8%, food products and live animals – 8,7%, chemicals and related products – 6,3%, and miscellaneous manufactured articles – 5,0%.

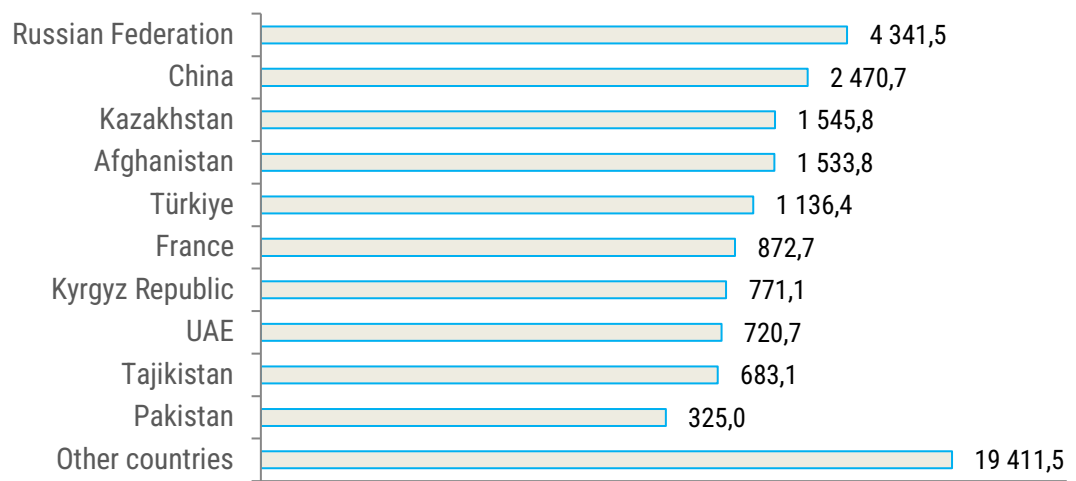

The main partners of Uzbekistan in the export of goods and services in foreign trade turnover for January-December 2025 were Russia (12,8%), China (7,3%), Kazakhstan (4,6%), Afghanistan (4,5%), Türkiye (3,4%), France (2,6%), the Kyrgyz Republic (2,3%), the UAE (2,1%), Tajikistan (2,0%), and Pakistan (1,0%). Their share in the total export volume exceeded 40.0%.

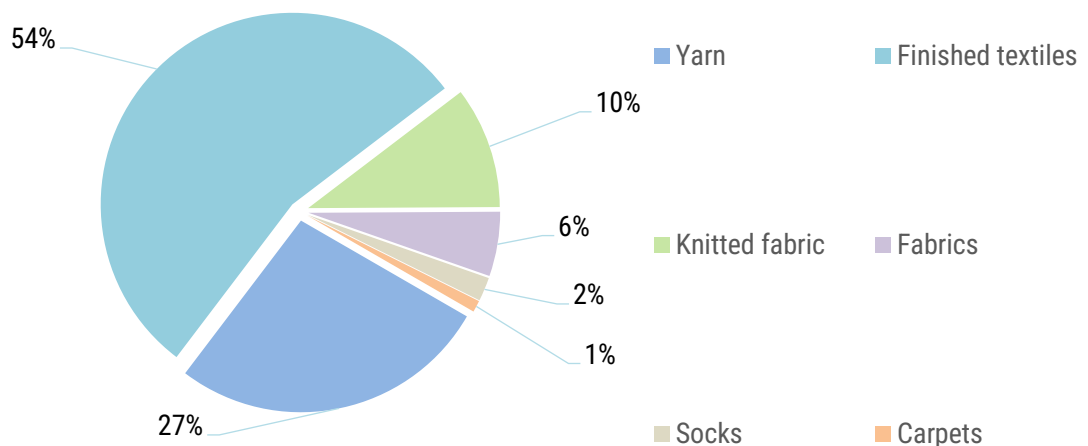

The volume of fruit and vegetable exports in the period under review reached 2 121.2 million USD (growth rate compared to 2024 was 36.9%). The share of fruit and vegetable products in the total volume of exports was 6.3%.

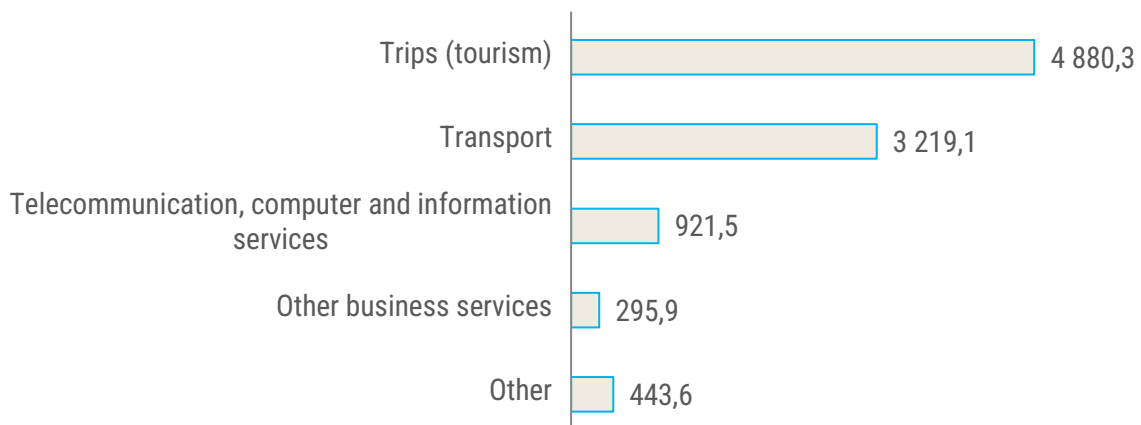
Export share of textile products



According to the results of January-December 2025, textile products were exported for a total of 2 632.5 million USD, which accounted for 7.8% of the total export volume and decreased by 8.2% compared to 2024.

In the structure of textile product exports, the main share is occupied by finished textile products (54.3%), as well as yarn (27.0%).

The volume of service exports for January-December 2025 amounted to 9 760.4 million USD, or 28.9% of the total trade export volume, and increased by 28.9% compared to 2024. In the structure of service exports, the main share is occupied by travel (tourism) (50.0%), transport services (33.0%), telecommunications, computer and information services (9.4%), and other business services (3.0%).

III. Import Volume

During this period, imports amounted to 47 354.5 million USD (compared to 2024, imports increased by 18.5%). The main share in its structure is occupied by machinery and transport equipment (33.8%), industrial goods (15.3%), as well as chemical substances and similar products (11.8%).

An analysis of the dynamics of goods imports showed that in January-December 2025, compared to 2024, the volume of goods imports increased by 6 794.2 million USD and amounted to 42 083.9 million USD, while the import of services reached 5 270.6 million USD.

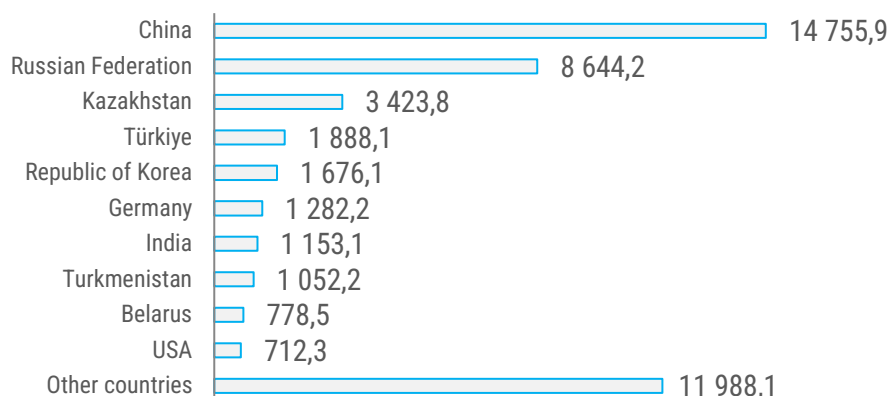

Overall, according to the results of January-December 2025, goods and services were imported to Uzbekistan from more than 180 countries. Over 60.0% of the total import volume comes from major partner countries such as China (31.2%), Russia (18.3%), Kazakhstan (7.2%), Türkiye (4.0%), the Republic of Korea (3.5%), Germany (2.7%), and India (2.4%).

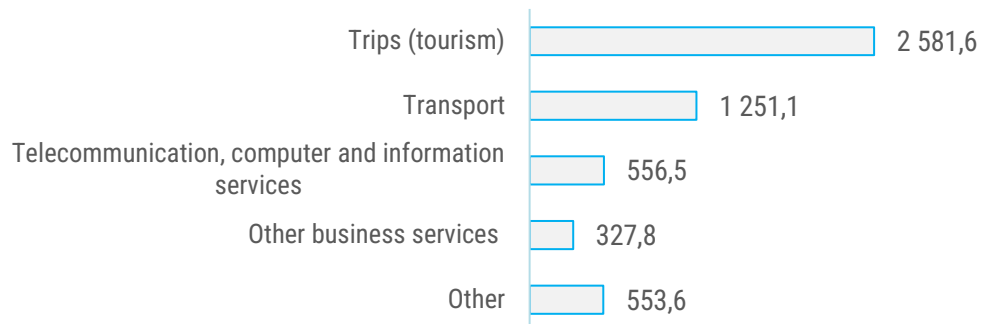

The volume of services imports for January-December 2025 amounted to 5 270.6 million USD, or 11.1% of its total volume, and increased by 12.7% compared to 2024.

In the structure of service imports, the main share is occupied by travel (tourism) (49.0%), transport services (23.7%), telecommunications, computer and information services (10.6%), as well as other business services (6.2%).

IV. Metadata

When compiling statistical indicators on foreign trade in goods of the Republic of Uzbekistan, along with the HS of FEA, the United Nations Standard International Trade Classification (SITC) is used, which allows for analytical purposes to group exported and imported goods into 10 major sections. The assignment of SITC codes to goods is carried out using conversion keys between the HS and SITC.

Foreign trade statistics are compiled based on data on foreign trade in goods and services: the initial data for foreign trade statistics are derived from customs cargo declarations of the Customs Committee and statistical observations of the National Statistics Committee on goods transferred from residents to non-residents that do not cross the state border and are not included in customs declarations; the compilation of foreign trade services statistics is carried out based on statistical observations.

In some cases, minor discrepancies between the total and the sum of components are explained by data rounding.
