



I. Number of enterprises and organizations

As of February 1, 2026, the number of enterprises and organizations operating in the republic is **572.7** thousand units, of which **411.1** thousand or **71.8 %** are small enterprises and microfirms.



Number of operating enterprises and organizations by type of economic activity

By type of economic activity, the largest number of operating enterprises and organizations remains in the trade sector, the share of which as of February 1, 2026 amounted to **27.2%**.

Enterprises and organizations



In second place is agriculture, forestry and fisheries with **22.0%**, in third place is industry with **10.6%**, in total the share of these three types of activity is over **59%** of their total.



II. Information on organizational and legal forms of business entities

Business entities



As of February 1, 2026, out of **415.2** thousand active commercial enterprises, limited liability companies accounted for **327.5** thousand (78.9%) and rank first among enterprises by their organizational and legal form.

Based on this, we can conclude that limited liability companies are the most common form of doing business.



As of February 1, 2026, the number of operating enterprises with foreign investment amounted to **18 513** units, of which **4 282** units are joint ventures, and **14 231** units are foreign enterprises.

By region, the largest share of operating enterprises with foreign investment is in Tashkent city and amounts to **63.1** %, in Tashkent – **13.3** %, Samarkand - **3.7** % and Fergana - **3.4** % regions.

Over the past five years, the total number of operating enterprises with foreign investment has increased by 1.9 times, and the share of operating only foreign enterprises (from the total number) has increased from 55.1% to 76.9%.



The number of enterprises operating with foreign investment as of February 1, 2026 increased by 3,350, or 22.1 percent, compared to the same period of 2025, due to an increase in the number of enterprises in the trade sector from 5 426 to 6 623 units (an increase of 1 197 units), industry - from 3 277 to 3 817 units (an increase of 540 units), construction from 1 122 to 1 444 units (an increase of 322 units).

Information on operating enterprises and organizations with foreign investments by country

As of February 1, 2026, China occupies the leading position – 5 218 enterprises with full or partial participation, which is 28.2% of the total number of operating enterprises with foreign investment in the republic. Among the countries pouring their capital into the economy of Uzbekistan, a special place is also occupied by the Russian Federation (17.2%), Turkey (11.6%), Kazakhstan (6.6%), South Korea (3.8%) and Afghanistan (3.5%).

IV. Metadata and explanations for the demography of enterprises and organizations

Information on enterprises and organizations is generated based on statistical classifiers in accordance with the Resolution of the Cabinet of Ministers of the Republic of Uzbekistan dated September 28, 2022, No. 539, "On approval of regulatory legal acts concerning the maintenance of the unified state register of enterprises and organizations and the provision of public services on its basis", which is the basis for the implementation of statistical activities on maintaining registers.

Information is received in the database of the Unified State Register of Enterprises and Organizations from registration authorities through an automated system in real time.

The data is generated based on the database of the State Services Center of the Ministry of Justice of the Republic of Uzbekistan as of **February 1, 2026** (from the register of farms and dehkan farms).
