



By type of economic activity, the largest number of operating enterprises and organizations remains in the trade sector, the share of which as of December 1, 2025 amounted to **32.5**%.



In second place is industry with 12.6% in third place is agriculture, forestry and fisheries with 7.3%.

Together, the share of these three types of activity is over **50**% of their total.



As of December 1, 2025, out of **405.5** thousand active commercial enterprises, limited liability companies accounted for **318.3** thousand (**78.5**%) and rank first among enterprises by their organizational and legal form.



Based on this, we can conclude that LLCs are the most common form of doing business.



By region, the largest share of operating enterprises with foreign investment is in Tashkent city and amounts to 63.5 %, in Tashkent - 13 %, Samarkand - 3.7 % and Fergana - 3.4 % regions.

Over the past five years, the total number of operating enterprises with foreign investment has increased by 1.9 times, and the share of operating only foreign enterprises (from the total number) has increased from 54.6% to 76.4%.

As of December 1, 2025, the number of operating enterprises with foreign investment amounted to 17 900 units, of which 4 228 units are joint ventures, and 13 672 units are foreign enterprises.



The number of enterprises operating with foreign investment as of December, 2025 increased by 2,450, or 15.9 percent, compared to the same period of 2024, due to an increase in the number of enterprises in the trade sector from 5 526 to 6 403 units (an increase of 877 units), industry - from 3 343 to 3 706 units (an increase of 363 units), construction from 1 146 to 1 389 units (an increase of 243 units).

China occupies the leading position – **4 873** enterprises with full or partial participation, which is **27.2**% of the total number of operating enterprises with foreign investment in the republic. Among the countries pouring their capital into the economy of Uzbekistan, a special place is also occupied by the Russian Federation (**17.9**%), Turkey (**11.8**%), Kazakhstan (**6.7**%), South Korea (**3.9**%) and Afghanistan (**3.6**%).

Information on enterprises and organizations is generated based on statistical classifiers in accordance with the Resolution of the Cabinet of Ministers of the Republic of Uzbekistan dated September 28, 2022, No. 539, "On approval of regulatory legal acts concerning the maintenance of the unified state register of enterprises and organizations and the provision of public services on its basis", which is the basis for the implementation of statistical activities on maintaining registers.

Information is received in the database of the Unified State Register of Enterprises and Organizations from registration authorities through an automated system in real time.

The data is generated based on the database of the State Services Center of the Ministry of Justice of the Republic of Uzbekistan as of **December 1, 2025** (excluding farms and dehkan farms).
