



I. Foreign trade turnover

In January-October 2025, the country's foreign trade turnover (FTT) amounted to 66.5 billion US dollars, and increased by 11 752.3 million US dollars, or 21.5 %, compared to the same period in 2024,





To the total volume of the FTT, exports amounted to 29 005.9 million US dollars (an increase of 27.8 % compared to January-October 2024), while imports reached 37 533.4 million US dollars (an increase of 16.9 % compared to January-October 2024). As a result, a negative trade balance of 8 527.5 million US dollars was observed.

The Republic of Uzbekistan maintains trade relations with 210 countries worldwide. The largest volume of foreign trade turnover was recorded with China (19.7 %), Russian Federation (15.9 %), Kazakhstan (5.9 %), Türkiye (3.7 %), and the Republic of Korea (2.2 %).

In the structure of exports, goods account for 73.3 %, of which industrial goods account for 10.9 %, food products and live animals - 8.2 %, chemical substances and similar products - 6.0 %, various finished products - 4.9 %.



The main partners of Uzbekistan in the export of goods and services in foreign trade turnover in January-October 2025 were Russian Federation (12.6 %), China (5.6 %), Kazakhstan (4.1 %), Afghanistan (4.1 %), Türkiye (3.2 %), France (2.7%), UAE (2.1 %), Kyrgyz Republic (1.7 %), Tajikistan (1.6 %) and Pakistan (1.1 %). Their share in the total volume of exports reached 38.8 %.



The volume of fruit and vegetable exports in the period under review reached 1 724.3 million US dollars (an increase of 39.7 %, compared to the same period in 2024). The share of fruit and vegetable products in the total volume of exports was 5.9 %.


Export share of textile products



According to the results of January-October 2025, the export of textile products amounted to 2 053.3 million US dollars, which amounted to 7.1 % of its total volume and compared to the same period in 2024, decreased by 15.5 %.

In the structure of exports of textile products, the main share is occupied by finished textile products (51.4 %), as well as yarn (28.5 %).





Indicators on the topic:

Export of services (by service type, monthly)

The volume of service exports for January-October 2025 amounted to 7 754.1 million US dollars, or 26.7 % of the total trade volume, and increased by 32.8 % compared to the same period in 2024. In the structure of exports of services, the main share is occupied by travel (tourism) (53.1 %) transport services (30.9 %), telecommunications, computer and information services (8.1 %), other business services (3.2 %).

III. Import Volume

Imports during this period amounted to 37 533.4 million US dollars (increase in growth rate, compared to January-October 2024, amounted to 16.9 %). The main share in its structure is occupied by machinery and transport equipment (34.0 %), industrial goods (15.8 %), as well as chemical substances and similar products (12.3 %).

Analysis of the dynamics of goods imports showed that in January-October 2025, compared to the same period in 2024, the volume of goods imports increased by 4 448.9 million US dollars and amounted to 33 466.7 million US dollars, while the import of services reached 4 066.7 million US dollars.





In total, according to the results of January-October 2025, goods and services were imported to Uzbekistan from 177 countries. More than two-thirds of imports come from major partner countries such as China (30.6 %), Russian Federation (18.5 %), Kazakhstan (7.3 %), Türkiye (4.0 %), the Republic of Korea (3.7 %), Germany (2.5 %), and India (2.5 %).



In the structure of imports of services, the main share is occupied by travel (tourism) (51.3 %), transport services (20.1 %), telecommunications, computer and information services (10.9 %), as well as other business services (6.6 %) and others (11.1 %).

IV. Metadata

When compiling statistical indicators on the Republic of Uzbekistan's foreign trade in goods, the United Nations Standard International Trade Classification (SITC) is used alongside the CN FEA. It allows for analytical grouping of exported and imported goods into 10 major sections. SITC codes are assigned to goods using transition keys between the CN FEA and SITC.

Foreign trade statistics are compiled based on data on foreign trade in goods and services: the initial data for compiling foreign trade statistics are data from cargo customs declarations of the Customs Committee and statistical observations of the National Statistics Committee on goods transferred from residents to non-residents that do not cross the state border and are not included in the customs declaration; statistics on foreign trade services are compiled based on statistical observations.
