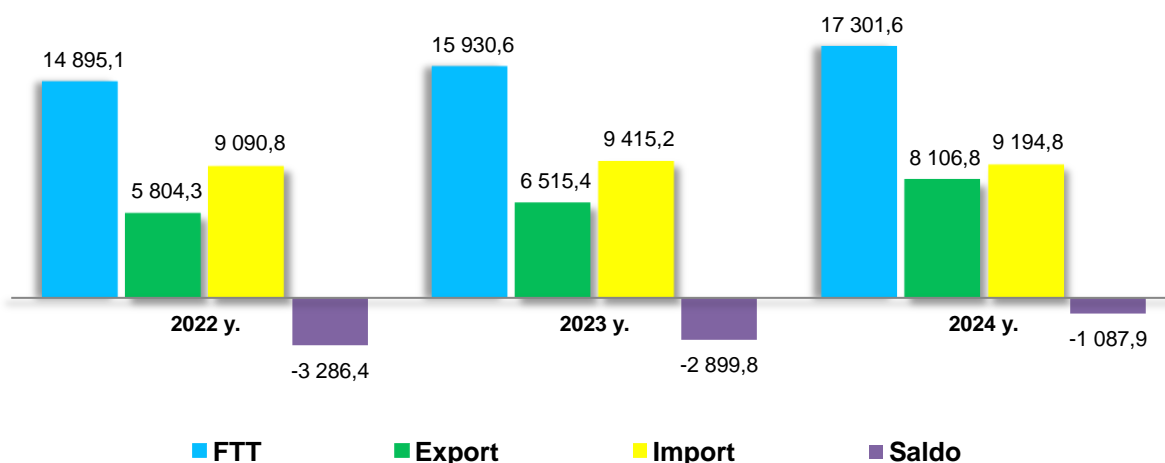

I. FOREIGN TRADE TURNOVER

In January-March 2025, the country's foreign trade turnover (FTT) amounted to 17.3 billion USD and increased, compared to the same period in 2024, by 1 371.0 million USD, or 8.6%.

Foreign trade turnover (USD million)



Of the total volume of WTO, exports amounted to 8 106.8 million USD (an increase of 24.4% was noted from January to March 2024), and imports amounted to 9 194.8 million USD (a decrease of 2.3%). As a result, the balance of foreign trade turnover amounted to a negative balance of - 1 087.9 million USD.

The Republic of Uzbekistan carries out trade relations with 173 countries of the world. The largest volume of foreign trade turnover is recorded with China (17.5%), Russia (14.9%), Kazakhstan (5.9%), Türkiye (3.5%) and the Republic of Korea (2.4%).

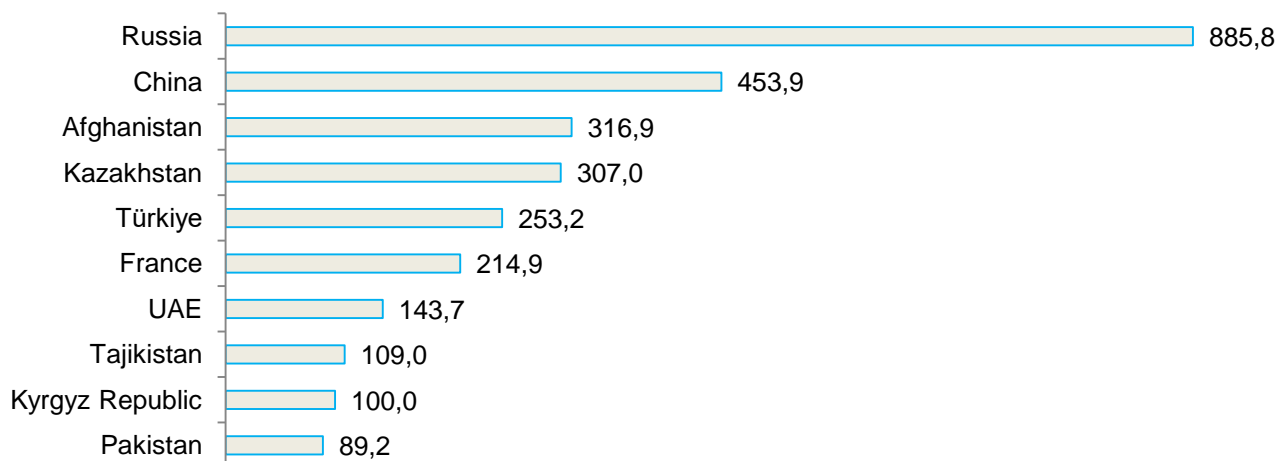

In the structure of exports, goods account for 78.6%, of which industrial goods account for 11.1%, food products and live animals – 5.8%, chemicals and similar products – 5.2%, various finished products – 3.5%.

Our main partners in the export of goods and services in foreign trade turnover in January-March 2025 were such countries as Russia (10.9%), China (5.6%), Afghanistan (3.9%), Kazakhstan (3.8%), Türkiye (3.1%), France (2.7%), the UAE (1.8%), Tajikistan (1.3%), the Kyrgyz Republic (1.2%), and Pakistan (1.1%). Their share in the total export volume reached 35.4%.

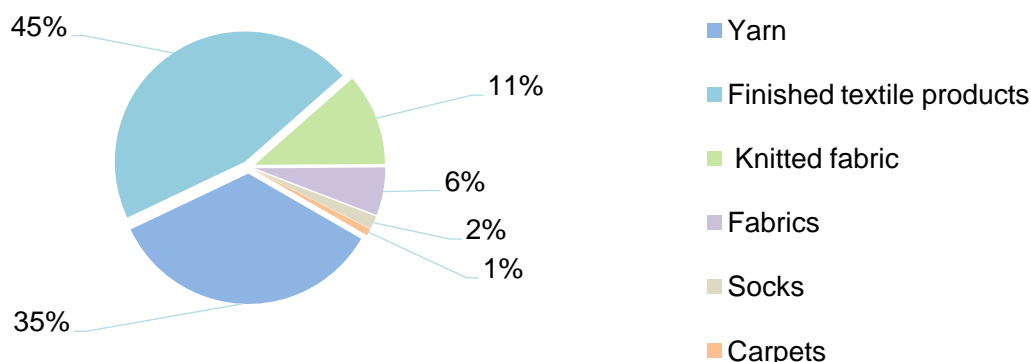

The volume of fruit and vegetable exports in the period under review amounted to 282.6 million USD (the growth rate, compared to the same period in 2024, amounted to 28.8%, respectively). In the total volume, exports amounted to 3.5%.

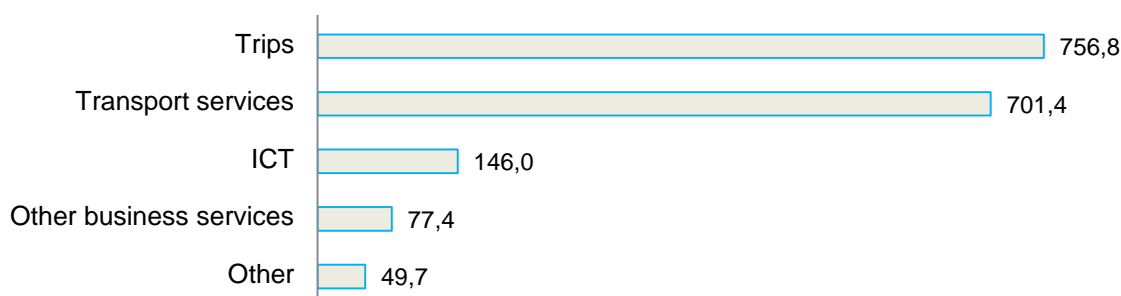
Export of textile products



According to the results of January-March 2025, textile exports amounted to 629.3 million USD, which amounted to 7.8% of the total volume and, compared to the same period in 2024, it decreased by 19.1%.

In the structure of textile exports, the main share is also occupied by finished textile products (45.0%), as well as yarn (35.0%).

The volume of services exports for January-March 2025 amounted to 1 731.3 million USD, or 21.4% of the total volume of trade exports, and increased by 37.9% compared to the same period in 2024. The largest share of service exports is made up of transportation services (40.5%), travel (tourism) (43.7%), telecommunications, computer and information services (8.4%), and other business services (4.5%).

At the same time, the largest share of other services (2.9%) is, respectively, insurance and pension services (1.0%), financial services (0.8%).

III. IMPORT VOLUME

During the reporting period, imports amounted to 9 194.8 USD million (a decrease in growth rates, compared to January-March 2024, amounted to 2.3%). The main share in its structure is occupied by machinery and transport equipment (35.1%), industrial goods (16.2%), as well as chemicals and similar products (13.1%).

Import structure of the Republic of Uzbekistan

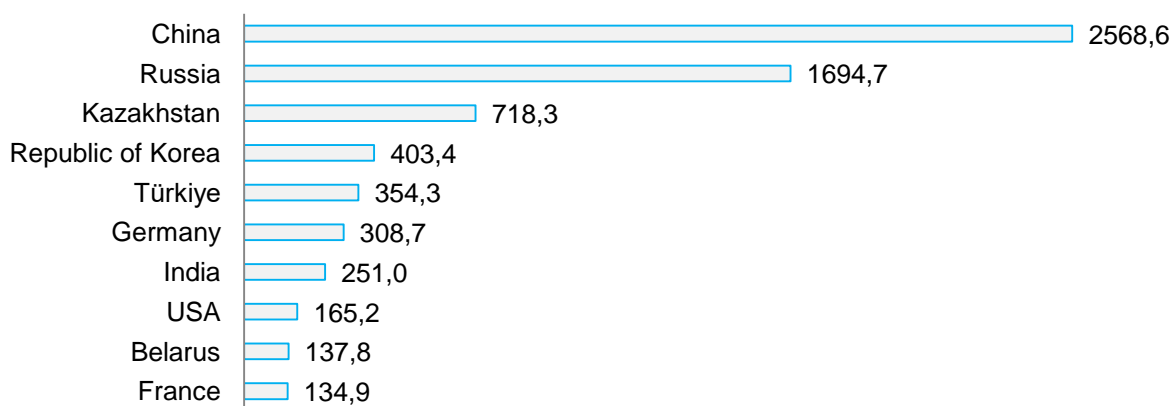

The analysis of the dynamics of imports of goods also showed that in January-March 2025, compared with the same period in 2024, the volume of imports of goods decreased by 460.1 million US dollars and amounted to 8 227.5 million US dollars, and imports of services reached 967.3 million US dollars.

In general, according to the results of January-March 2025, goods and services were imported to Uzbekistan from 151 countries. More than 2/3 of imports come from such large partner countries as China (27.9%), Russia (18.4%), Kazakhstan (7.8%), the Republic of Korea (4.4%), Türkiye (3.9%), Germany (3.4%) and India (2.7%).

Structure of imported goods by sections of SITC (at the 2-character level)

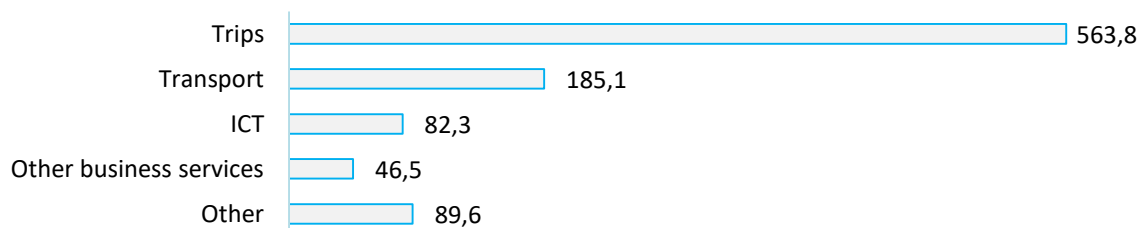

The volume of imports of services for January-March 2025 amounted to 967.3 million USD, or 10.5% of the total volume, and increased by 32.9% compared to the same period in 2024.

The main share of imports of services is made up of travel (tourism 58.3%), transport services (19.1%), telecommunications, computer and information services (8.5%), and other business services (4.8%).

IV. METADATA

In forming statistical indicators on foreign trade in goods of the Republic of Uzbekistan, along with the TN FEA, the International Standard Trade Classification of the United Nations (ISTC) is used, which allows for analytical purposes to group exported and imported goods into 10 large sections. Assignment of ISTC codes to goods is carried out using transition keys between the TN FEA and ISTC.

Foreign trade statistics are formed on the basis of data on foreign trade in goods and services: the initial data for the formation of statistics on foreign trade in goods are data from cargo customs declarations of the Customs Committee and statistical observations of the National Statistics Committee on goods moved from residents to non-residents that do not cross the state border and are not included in the customs declaration; the formation of statistics on foreign trade services is carried out on the basis of statistical observations.
