

I. FOREIGN TRADE TURNOVER

In January-August 2025, the country's foreign trade turnover (FTT) amounted to 51.4 billion US dollars, an increase of 8,489.0 million US dollars, or 19.8 %, compared to the same period in 2024.

To the total FTT volume, exports amounted to 22,981.5 million US dollars (an increase of 31.3 % compared to January-July 2024), while imports reached 28,453.7 million US dollars (an increase of 11.8 % compared to January-July 2024). As a result, the foreign trade balance amounted to a negative balance of 5,472.2 million US dollars.



The Republic of Uzbekistan trades with 200 countries. The largest foreign trade turnover is with China (18.9 %), Russia (16.1 %), Kazakhstan (5.9 %), Türkiye (3.7 %), and the Republic of Korea (2.2 %).

In the export structure, goods account for 75.2 %, of which industrial goods account for 11.1 %, food products and live animals – 7.8 %, chemicals and similar products – 5.9 %, mineral fuels, lubricants and similar materials – 4.4 %.

Our main partners for the export of goods and services in foreign trade turnover in January-August 2025 were Russia (12.5 %), China (5.4 %), Kazakhstan (4.0 %), Afghanistan (3.8 %), Türkiye (3.2 %), France (2.7 %), the UAE (2.1 %), the Kyrgyz Republic (1.6 %), Tajikistan (1.5 %), and Pakistan (1.2 %). Their share of total exports reached 38.0 %.


In January-August 2025, 1 458.6 thousand tons of fruit and vegetable products were exported, and, compared to the same period in 2024, this figure increased by 7.3 %, or 99.8 thousand tons.

The volume of fruit and vegetable exports in the period under review reached 1 266.4 million US dollars (an increase of 37.3 % compared to the same period in 2024). Exports accounted for 5.5 % to the total volume.

The share of textile exports




According to the results of January-August 2025, textile exports amounted to 1 667.8 million US dollars, which amounted to 7.3 % to the total volume and, compared to the same period in 2024, decreased by 17.0 %.

In the structure of textile exports, the main share is occupied by finished textile products (50 %), as well as yarn (30 %).

The volume of services exports for the period January–August 2025 amounted to 5 707.9 million US dollars, or 24.8 % to the total volume of trade exports, and increased by 28.6 % compared to the same period in 2024. The main share of services exports is made up of travel (tourism) (53.6 %), transportation services (32.0 %), telecommunications, computer and information services (7.9 %), and other business services (2.6 %).

III. IMPORT VOLUME

During this period, imports totaled 28 453.7 million US dollars (an increase of 11.8 % compared to January–August 2024). The largest share of these imports was made up of machinery and transport equipment (33.8 %), industrial goods (16.1 %), and chemicals and similar products (12.6 %).

An analysis of the dynamics of goods imports showed that in January–August 2025, compared to the same period in 2024, the volume of goods imports increased by 2 359.9 million US dollars and amounted to 25 529.3 million, while the import of services reached 2 924.5 million US dollars.

Import structure of the Republic of Uzbekistan



Overall, from January to August 2025, Uzbekistan imported goods and services from 170 countries. Over two-thirds of imports came from major partner countries such as China (29.7 %), Russia (19.1 %), Kazakhstan (7.4 %), Türkiye (4.1 %), the Republic of Korea (3.9 %), Germany (2.7 %), and India (2.6 %).



The volume of service imports for January-August 2025 amounted to 2 924.5 million US dollars, or 10.3 % to the total volume, and increased by 28.6 % compared to the same period in 2024.

The main share of service imports is made up of travel (tourism 56.8 %), transport services (18.0 %), telecommunications, computer and information services (9.7 %), as well as other business services (5.4 %) and others (10.0 %).

IV. METADATA

When compiling statistical indicators on the Republic of Uzbekistan's foreign trade in goods, the United Nations Standard International Trade Classification (SITC) is used alongside the CN FEA. It allows for analytical grouping of exported and imported goods into 10 major sections. SITC codes are assigned to goods using transition keys between the CN FEA and SITC.

Foreign trade statistics are compiled based on data on foreign trade in goods and services: the initial data for compiling foreign trade statistics are data from cargo customs declarations of the Customs Committee and statistical observations of the National Statistics Committee on goods transferred from residents to non-residents that do not cross the state border and are not included in the customs declaration; statistics on foreign trade services are compiled based on statistical observations.
