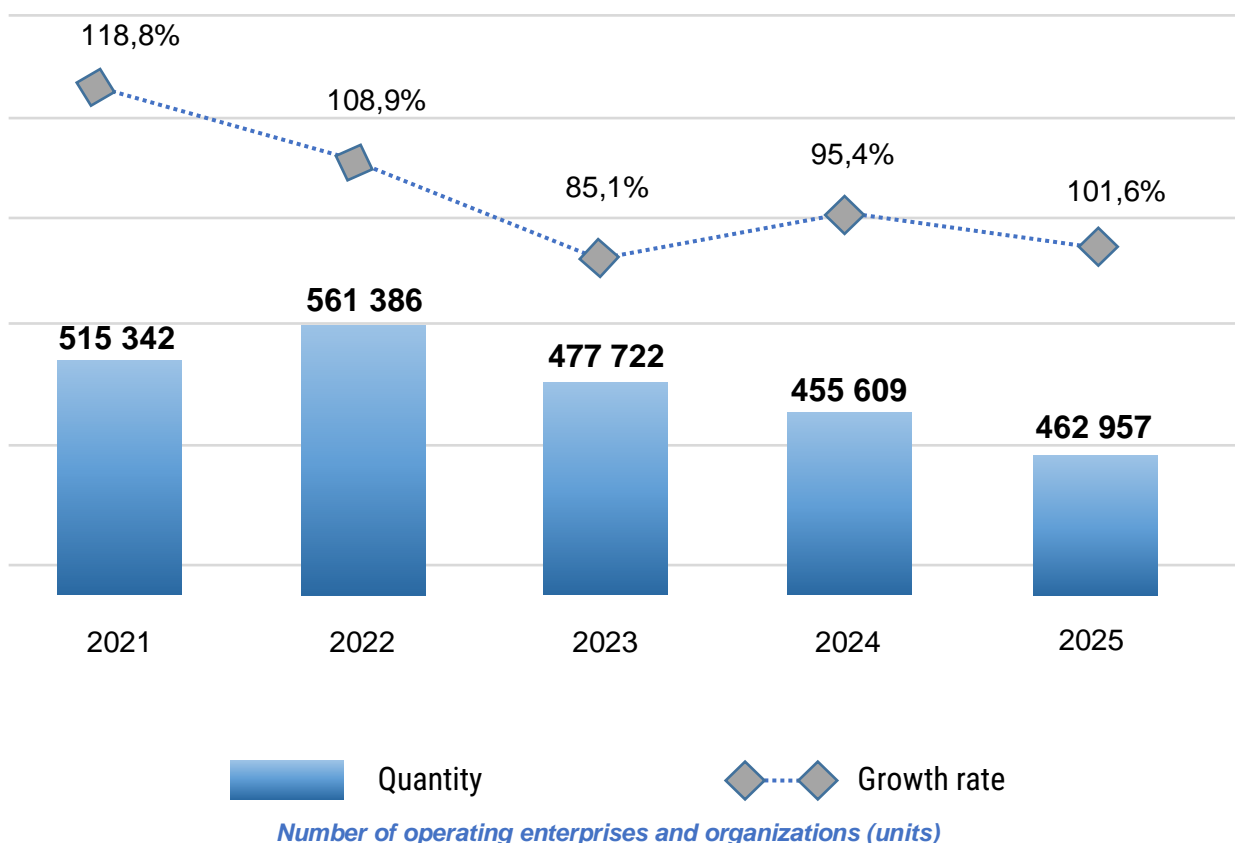

I. Number of enterprises and organizations

As of July 1, 2025, the number of enterprises and organizations operating in the republic is 463.0 thousand units, of which 393.4 thousand or 85.0 % are small enterprises and microfirms.

In the regional context, the largest number of operating enterprises and organizations operate in Tashkent city - 22.5 %, Tashkent - 9.6 %, Samarkand - 8.7 %, Fergana - 8.1 % and Kashkadarya - 6.5 % regions.

A significant share of business entities in the total number of enterprises and organizations is recorded in Tashkent city - 90.3 %, Navoi - 88.0 %, Khorezm - 87.5 % and Bukhara - 87.0 % regions.

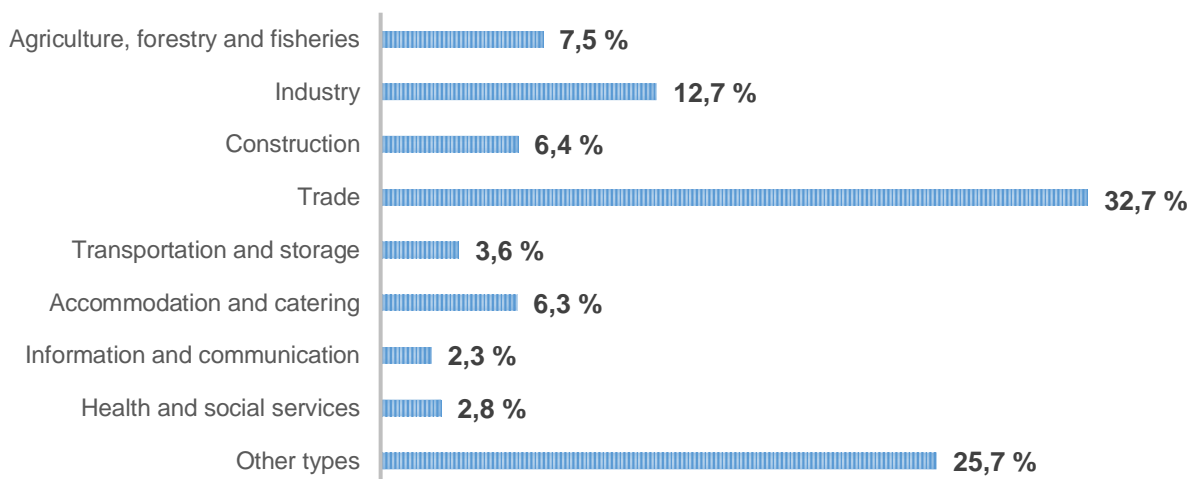

Number of operating enterprises and organizations by type of economic activity

By type of economic activity, the largest number of operating enterprises and organizations remains in the trade sector, the share of which as of July 1, 2025 amounted to 32.7%.

In second place is industry with 12.7%, in third place is agriculture, forestry and fisheries with 7.5%.

Together, the share of these three types of activity is over 50% of their total.

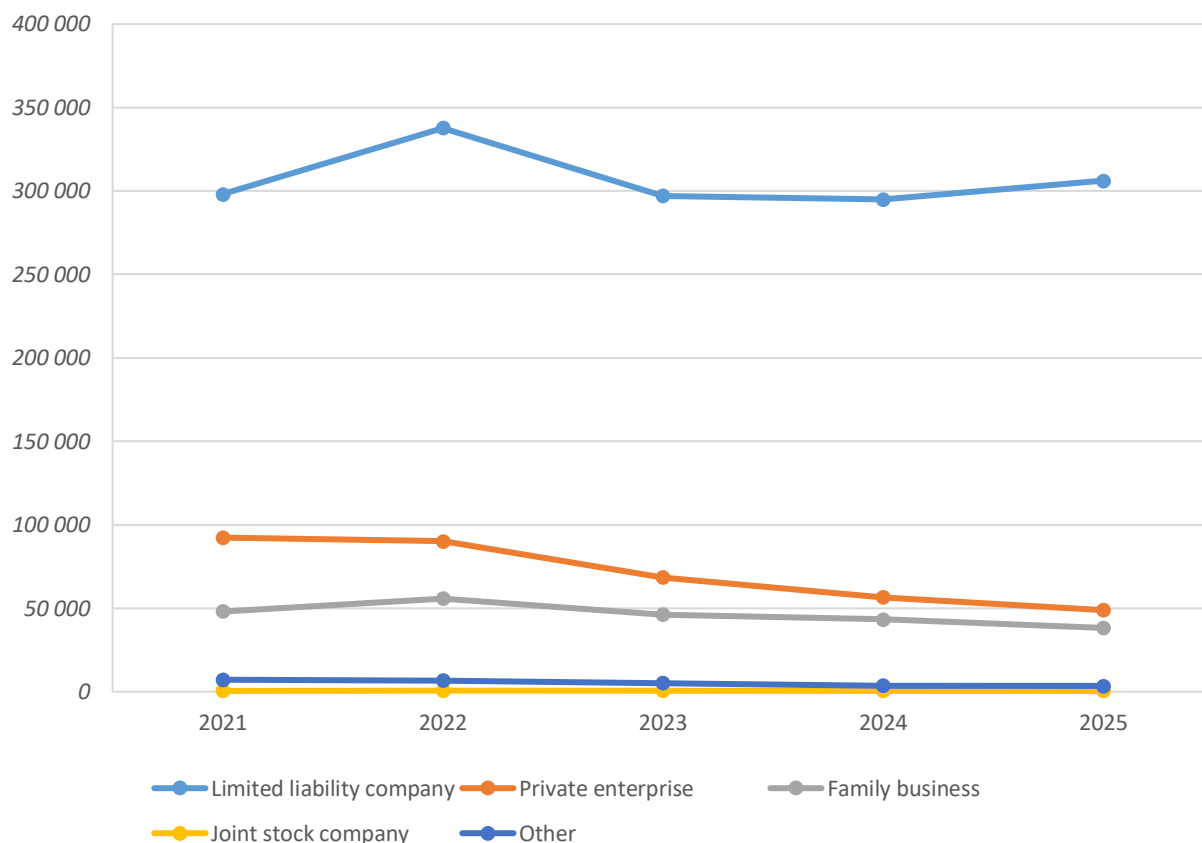

II. Information on organizational and legal forms of business entities

As of July 1, 2025, out of 397.3 thousand active commercial enterprises, limited liability companies accounted for 306.0 thousand (77.0%) and rank first among enterprises by their organizational and legal form. It should be noted that since 2022, the number of private and family enterprises has gradually decreased.



Business entities

Based on this, we can conclude that LLCs are the most common form of doing business in the country.

III. Information on enterprises and organizations with foreign investments

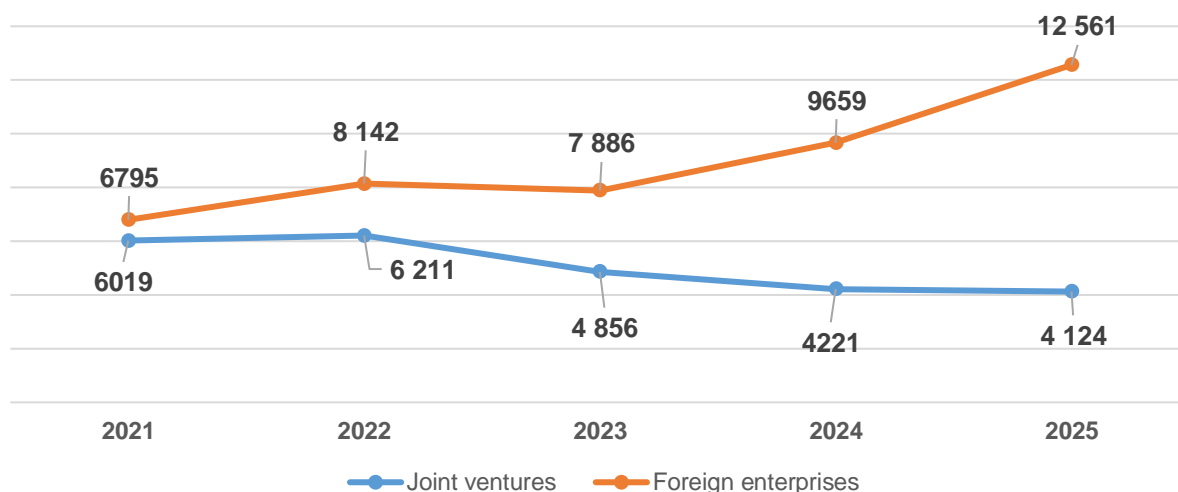
In order to create the most favorable investment climate in the country to attract direct investment, large-scale measures have been implemented to liberalize the economy, limit interference in the activities of business entities, reduce and simplify licensing and permitting procedures, ensure free access to goods (works and services), and create the necessary infrastructure in the regions. As a result, the number of enterprises with foreign investment has grown every year.

By region, the largest share of operating enterprises with foreign investment is in Tashkent city and amounts to 64.2 %, in Tashkent - 12.3 %, Samarkand - 3.7 % and Surkhandarya - 3.3 % regions.

Over the past five years, the total number of operating enterprises with foreign investment has increased by 1.3 times, and the share of operating only foreign enterprises (from the total number) has increased from 53.0% to 75.3%.

As of July 1, 2025, the number of operating enterprises with foreign investment amounted to 16 685 units, of which 4 124 units are joint ventures, and 12 561 units are foreign enterprises.



Enterprises and organizations with foreign investment

The number of operating enterprises with foreign investment as of July 1, 2025 increased by 2 805 units compared to the corresponding period of 2024, due to an increase in the number of enterprises in the trade sector from 4 833 to 6 038 units (an increase of 1 205 units), information and communications - from 954 to 1 210 units (an increase of 256 units), construction from 985 to 1 256 units (an increase of 271 units).

Information on operating enterprises and organizations with foreign investments by country

China occupies the leading position – 4 192 enterprises with full or partial participation, which is 25.1% of the total number of operating enterprises with foreign investment in the republic. Among the countries pouring their capital into the economy of Uzbekistan, a special place is also occupied by the Russian Federation (18.6%), Türkiye (12.0%), Kazakhstan (6.9%), Afghanistan (4.1%) and South Korea (4.1%).

IV. Metadata and explanations for the demography of enterprises and organizations

Information on enterprises and organizations is generated based on statistical classifiers in accordance with the Resolution of the Cabinet of Ministers of the Republic of Uzbekistan dated September 28, 2022 No. 539 "On approval of regulatory legal acts concerning the maintenance of the unified state register of enterprises and organizations and the provision of public services on its basis", which is the basis for the implementation of statistical activities on maintaining registers.

Information is received in the database of the Unified State Register of Enterprises and Organizations from registration authorities through an automated system in real time.

The data is generated based on the database of the State Services Center of the Ministry of Justice of the Republic of Uzbekistan as of **July 1, 2025** (excluding farms and dehkan farms).
