



I. Number of enterprises and organizations

As of April 1, 2025, the number of enterprises and organizations operating in the republic is 442.4 thousand units, of which 372.9 thousand or 84.3 % are small enterprises and microfirms.

In the regional context, the largest number of operating enterprises and organizations operate in the city of Tashkent - 22.6 %, Tashkent - 9.6 %, Samarkand - 8.8 %, Fergana - 8.1 % and Kashkadarya - 6.5 % regions.

A significant share of business entities in the total number of enterprises and organizations is recorded in the city of Tashkent - 90.0 %, Navoi - 87.5 %, Khorezm - 87.0 % and Bukhara - 86.7 % regions.



By type of economic activity, the largest number of operating enterprises and organizations remains in the trade sector, the share of which as of April 1, 2025 amounted to 32.6%.





II. Information on organizational and legal forms of business entities

Of the 377.6 thousand active commercial enterprises as of April 1, 2025, limited liability companies accounted for 288.8 thousand and rank first among enterprises by their organizational and legal form.


Based on this, we can conclude that LLCs are the most common form of doing business in the country.

III. Information on enterprises and organizations with foreign investments

As of April 1, 2025, the number of operating enterprises with foreign investment amounted to 15 739 units, of which 4 031 units are joint ventures, and 11 708 units are foreign enterprises.

Over the past five years, the total number of operating enterprises with foreign investment has increased by 1.3 times, and the share of operating only foreign enterprises (from the total number) has increased from 52.6% to 74.4%.



Enterprises and organizations with foreign investment

The number of operating enterprises with foreign investment as of April 1, 2025 increased by 1 513 units compared to the corresponding period of 2024, due to an increase in the number of enterprises in the trade sector from 5 056 to 5 686 units (an increase of 630 units), information and communications - from 917 to 1 131 units (an increase of 214 units), construction from 956 to 1 146 units (an increase of 190 units).

Information on operating enterprises and organizations with foreign investments by country

China occupies the leading position – 3 711 enterprises with full or partial participation, which is 23.6% of the total number of operating enterprises with foreign investment in the republic. Among the countries pouring their capital into the economy of Uzbekistan, a special place is also occupied by the Russian Federation (19.3%), Turkey (12.3%), Kazakhstan (6.9%) and South Korea (4.2%).

IV. Metadata and explanations for the demography of enterprises and organizations

Information on enterprises and organizations is generated based on statistical classifiers in accordance with the Resolution of the Cabinet of Ministers of the Republic of Uzbekistan dated September 28, 2022 No. 539 "On approval of regulatory legal acts concerning the maintenance of the unified state register of enterprises and organizations and the provision of public services on its basis", which is the basis for the implementation of statistical activities on maintaining registers.

Information is received in the database of the Unified State Register of Enterprises and Organizations from registration authorities through an automated system in real time.

The data is generated based on the database of the State Services Center of the Ministry of Justice of the Republic of Uzbekistan as of **April 1, 2025** (excluding farms and dehkan farms).
