



Preliminary data

The retail trade turnover in January-October 2020 reached 154 496.6 billion soums and increased by 1.2% compared to the same period in 2019, also the turnover of large enterprises amounted to 28 357.1 billion soums (growth rates -121.4%), and small business and private entrepreneurship - 115 445.9 billion soums (growth rate - 100.6%), including unorganized trade amounted to 10 693.6 billion soums (growth rate - 73, 0%).

GENERAL INFORMATION

The retail trade turnover in January-October 2020 reached 154 496.6 billion soums and increased by 1.2% compared to the same period last year.

Compared to the corresponding period of last year, in all regions, except for the Republic of Karakalpakstan, Bukhara, Jizzakh, Navoi, Namangan, Samarkand, Tashkent regions and the city of Tashkent, there was a decrease in growth rates in retail trade.

SMALLEST SHARE OF REGIONS

In the structure of retail trade turnover, the smallest share was recorded at the level of 1.9%, or 2 932.7 billion soums, which was noted in the Syrdarya region.



Compared to the same period last year, in Andijan (99.4%), Surkhandarya (94.1%), Khorezm (96.3%), Syrdarya (97.1%) and Kashkadarya (97.5%) regions were noted slower growth in retail trade. Along with this, insignificant growth rates were noted in Tashkent city (103.7%), Tashkent (104.5%) and Samarkand (105.1%) regions.

Regions with the largest share of large enterprises in retail trade, in %




In the structure of retail trade turnover, the turnover of large enterprises increased by 21.4% and reached 28 357.1 billion soums, which is 18.4% of its total volume.

Regions with the largest share of small business and private entrepreneurship in retail trade, in %




The turnover of retail trade of small business and private entrepreneurship, according to statistical calculations, amounted to 126 139.5 billion soums and, compared to the same period last year, decreased by 2.5%. The share of this sector in the republic in the retail trade turnover reached 81.6%.

The share of small business and private entrepreneurship, in comparison with other regions, was the largest in Kashkadarya (93.4%), Jizzakh (92.6%), Surkhandarya (91.2%), Namangan (90.5%) regions, the Republic of Karakalpakstan (90.1%) and Fergana (89.0%) regions. In the structure of retail trade turnover, the share of turnover of large enterprises amounted to 18.4% of the total sales, their main share was observed in Tashkent city (35.0%), Samarkand (22.4%), Navoi (20.0%) and Tashkent (17.1%) regions.





VOLUME AND RATE OF GROWTH PER CAPITA IN RETAIL TRADE TURNOVER

The retail trade turnover per capita in the republic in January-October 2020 averaged 4 524.9 thousand soums (compared to the same period last year, it decreased by 0.8%).

This indicator, in comparison with other regions, was larger in Tashkent city (13 176.1 thousand soums), Navoi (5 691.8 thousand soums) and Tashkent (5 578.3 thousand soums) regions.



Structure of the turnover of unorganized trade, in %



According to preliminary data from a survey of individuals, the turnover of unorganized trade in January-October 2020 amounted to 10 693.6 billion soums and, compared to the same period last year, decreased by 27.0%. Including the turnover of trade in the dekhkan markets amounted to 5 486.2 billion soums (a decrease of 24.9%), the turnover of trade in the livestock markets was recorded at the level of 5 207.4 billion soums (a decrease of 29.1%).

TURNOVER OF UNORGANIZED TRADE : DEKHGAN MARKETS



In January-October 2020, in all regions of the republic, a survey of individuals engaged in the sale of agricultural products (grown in personal subsidiary plots) was carried out, according to the results of which the turnover of this type of trade amounted to 5 486.2 billion soums. High sales of fresh agricultural products reached 2 449.2 billion soums.



TURNOVER OF UNORGANIZED TRADE : LIVESTOCK MARKETS



In January-October 2020, a survey of individuals involved in the sale of poultry and livestock (kept in personal subsidiary plots) was conducted in all regions of the republic, according to the results of which the turnover of this type of trade amounted to 5 207.4 billion soums. The sale of livestock of different ages reached 4 096.8 billion soums, sheep and goats - 974.2 billion soums, horses - 111.4 billion soums, birds - 25.0 billion soums.

In January-October 2020, the share of trade turnover of public catering enterprises in the structure of retail trade turnover amounted to 2.6%, reaching 3 953.4 billion soums, and decreased by 10.2% compared to the same period last year. Of these, 83.8% of the trade turnover falls on the share of small businesses.





The turnover of public catering in the period under review amounted to 3 953.4 billion soums (against January-October 2019 - 89.8%), by type of ownership: non-state - 3 848.8 billion soums and state - 104.6 billion soums. Compared to the same period last year, the turnover of public catering enterprises of state ownership decreased from 5.0% to 2.6%.

Structure of wholesale trade turnover, in %





According to preliminary data, in January-October 2020, the volume of wholesale trade reached 86 591.2 billion soums and, compared to the same period last year, increased by 0.5%. The turnover of wholesale trade of small businesses, according to statistical calculations, amounted to 60 284.2 billion soums and, in comparison with the corresponding period of last year, decreased by 7.4%. The share of this sector in the wholesale trade turnover in the republic amounted to 69.6%.

The highest growth rates of the wholesale trade turnover of large enterprises, compared with last year, were observed in Tashkent city (107.4%), Namangan (102.2%), Andijan (142.4%) and Surkhandarya (101.2%) regions.



WHOLESALE TRADE TURNOVER BY FORM OF OWNERSHIP

In recent years, the role of the public sector in the total volume of wholesale trade has been steadily decreasing. So, for the reporting period, the share of this sector was fixed at the level of 0.1% of the total volume of wholesale trade. Wholesale trade turnover in January-October 2020 amounted to 86 591.2 billion soums, including entities of non-state ownership – 86 485.6 billion soums, state ownership - 105.6 billion soums.



Analysis of the share of wholesale trade by type of ownership showed that there is still an insignificant share of state property in Tashkent city (0.2%), Navoi (0.1%), Andijan (0.04%) regions. In other regions, wholesale trade is generally a non-state form of ownership.
