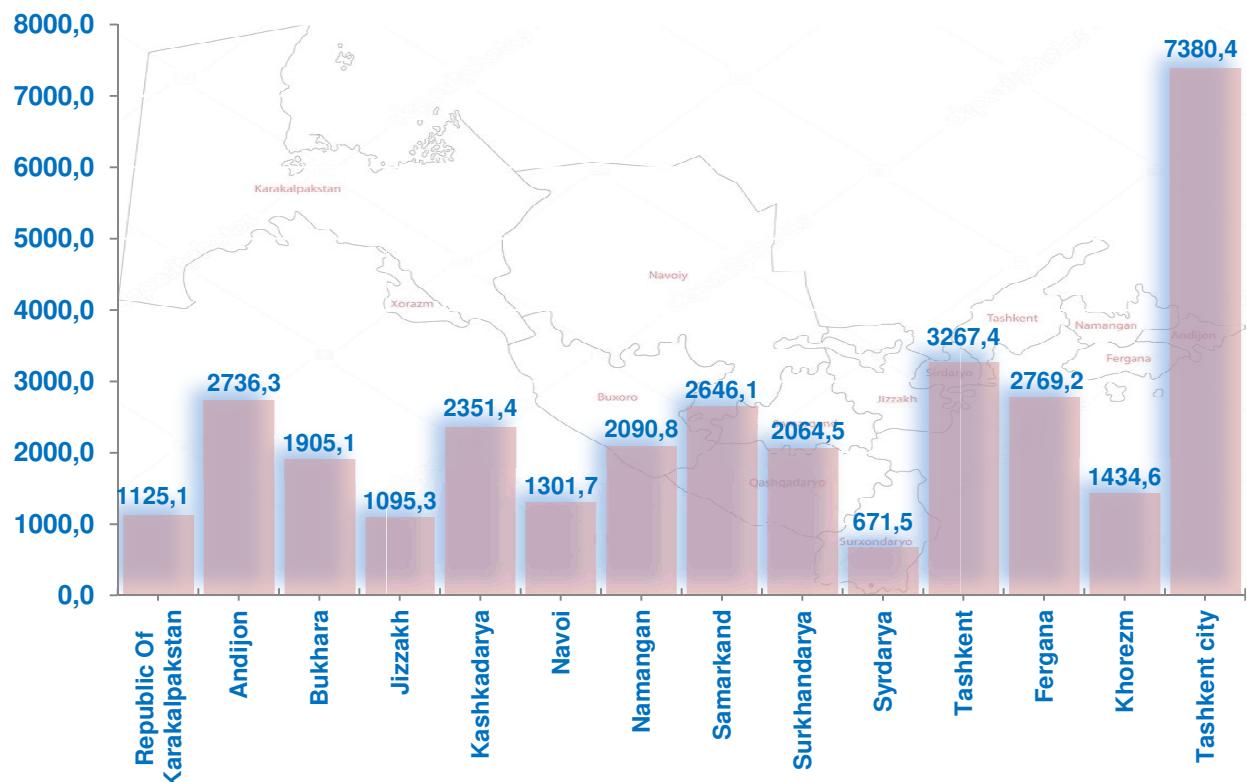


RETAIL TRADE TURNOVER REPUBLIC OF UZBEKISTAN
(January-March 2019*)

Retail trade turnover in January-March this year reached 32 839.4 billion UZS and increased, compared to the same period last year, by 5.9 %, the turnover of large enterprises reached 5 020.9 billion UZS (growth rate of 28.0 %), small businesses – 27 818.5 billion UZS (growth rate of 2.7 %). Of the total turnover of small businesses selling goods in unorganized trade amounted to 3 301.3 billion UZS (compared to the same period last year, a decrease of 6.1 %).

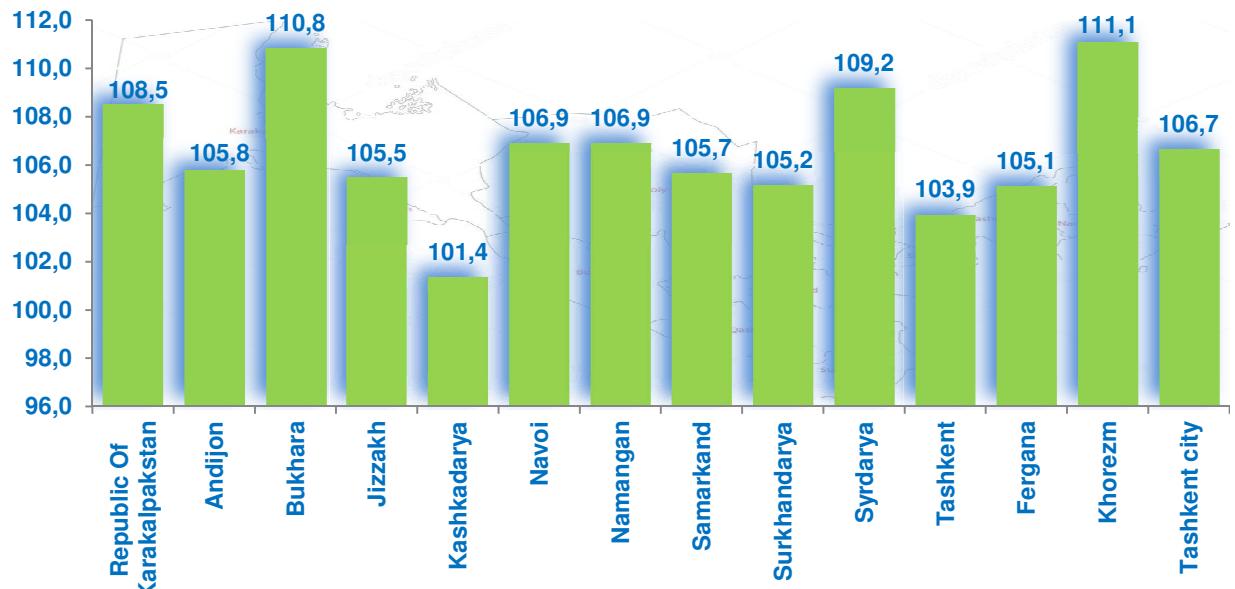
**Volume of retail trade turnover by regions

Compared to the same period last year, in all regions of the Republic there was an increase in the growth rate in retail trade. At the same time, relatively high growth rates were observed in Khorezm, Bukhara regions and the Republic of Karakalpakstan..

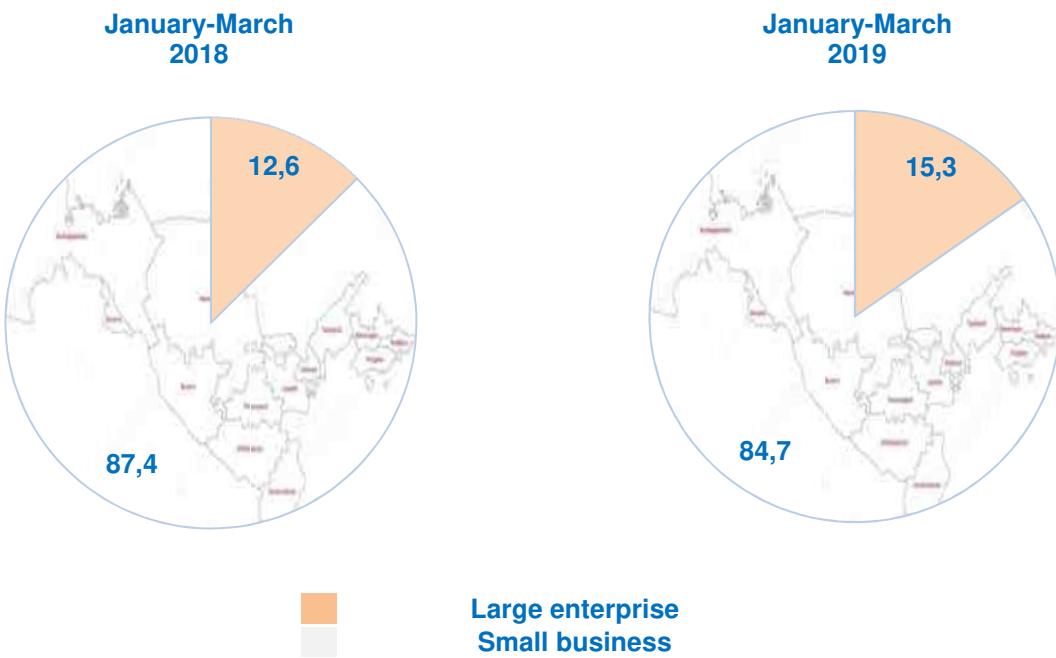
The growth rate of retail trade turnover, %



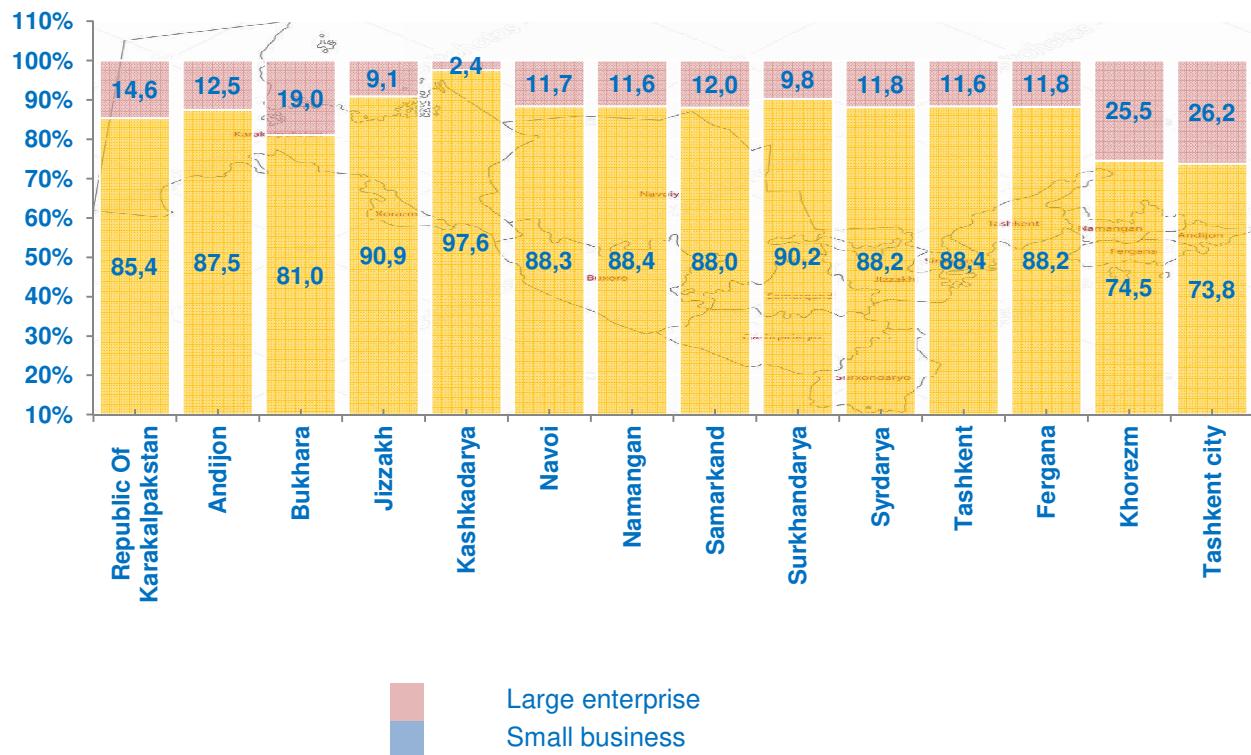
In the structure of retail trade turnover, the volume of trade turnover of large enterprises increased by 28.0% compared to the same period last year and reached 5 020.9 billion UZS, which is 15.3 % of total sales.

The turnover of retail trade of small businesses, according to statistical calculations, amounted to 27 818.5 billion UZS and, in comparison with the same period last year, increased by 2.7 %. The share of this sector in the country's retail trade turnover reached 84.7 %.

The share of small business in comparison with other regions was higher in Kashkadarya (97.6%), Jizzakh (90.7%), Surkhandarya (90.2%), Tashkent (88.4%) and Namangan (88.4%) regions.

In the structure of retail trade turnover, the share of trade turnover of large enterprises is 15.3 % of total sales, the main share was observed in Tashkent (26.2 %), Khorezm (25.5%) and Bukhara (19.0 %) regions.

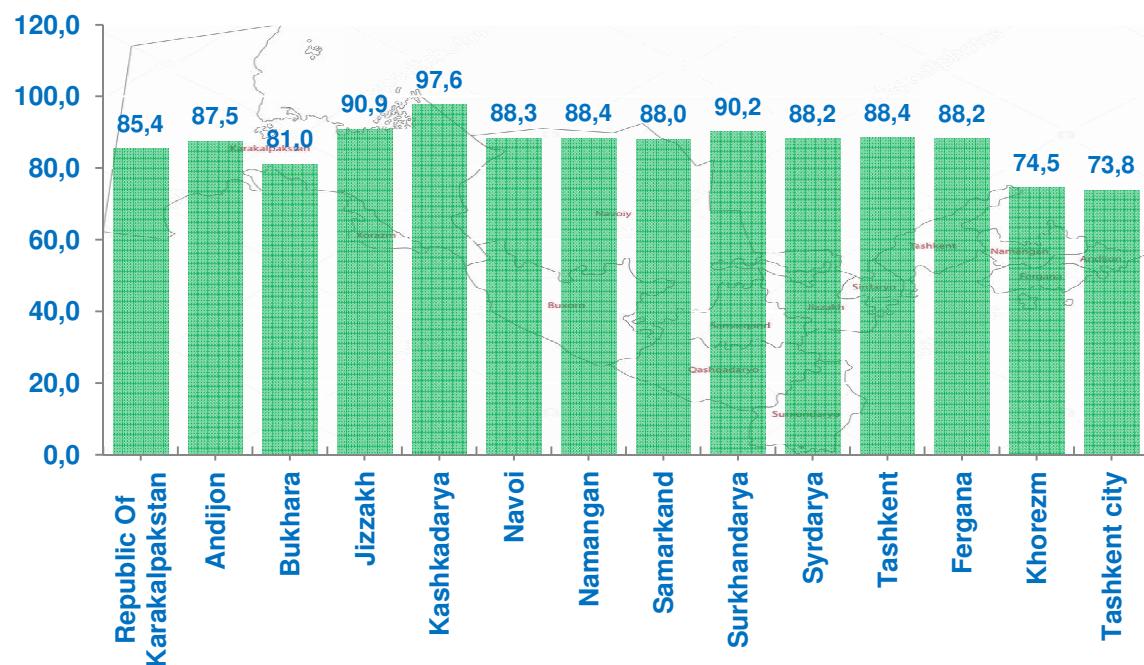

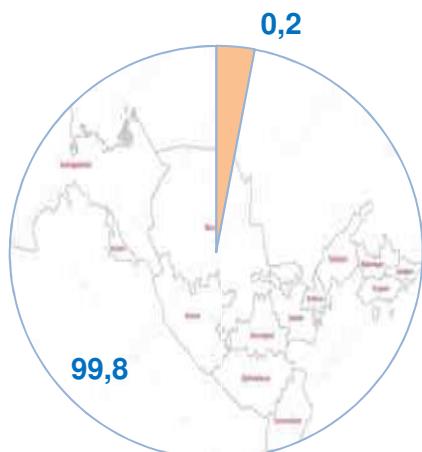

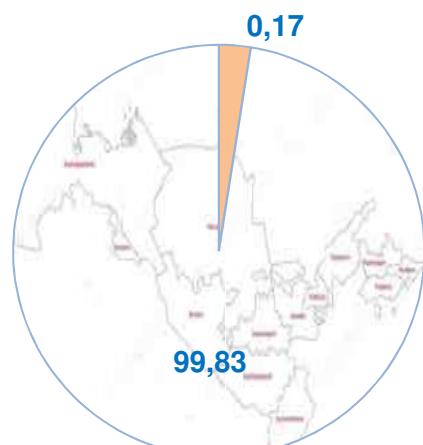


Share of retail turnover

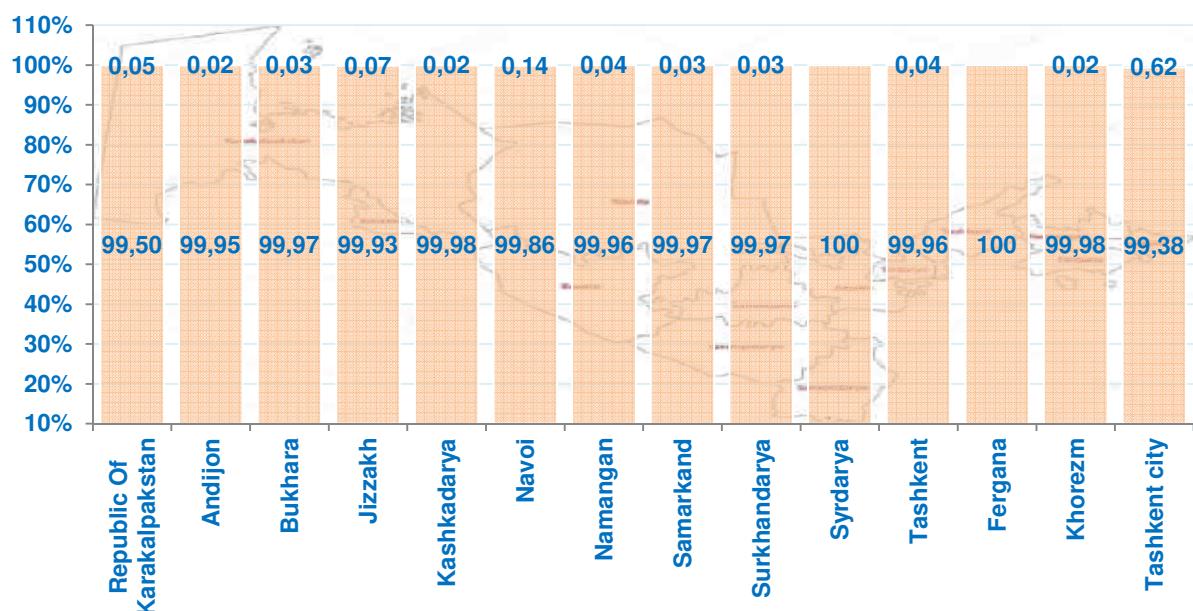

Retail trade turnover per capita in all regions of the Republic (except Kashkadarya (99.3%) region) increased, compared to the same period last year.

This indicator, in comparison with other regions, was more in Tashkent (2 932,9 thousand sum), Navoi (1 326,8 thousand sum) and Tashkent (1 125,6 thousand sum) regions. This can be explained by the location of large commercial and industrial enterprises in these regions.

Retail trade turnover per capita in the Republic in January-March 2019 averaged 985.7 thousand UZS (compared to the same period last year, it increased by 4.0 %). These indicators in the context of the regions of the Republic are clearly illustrated below:

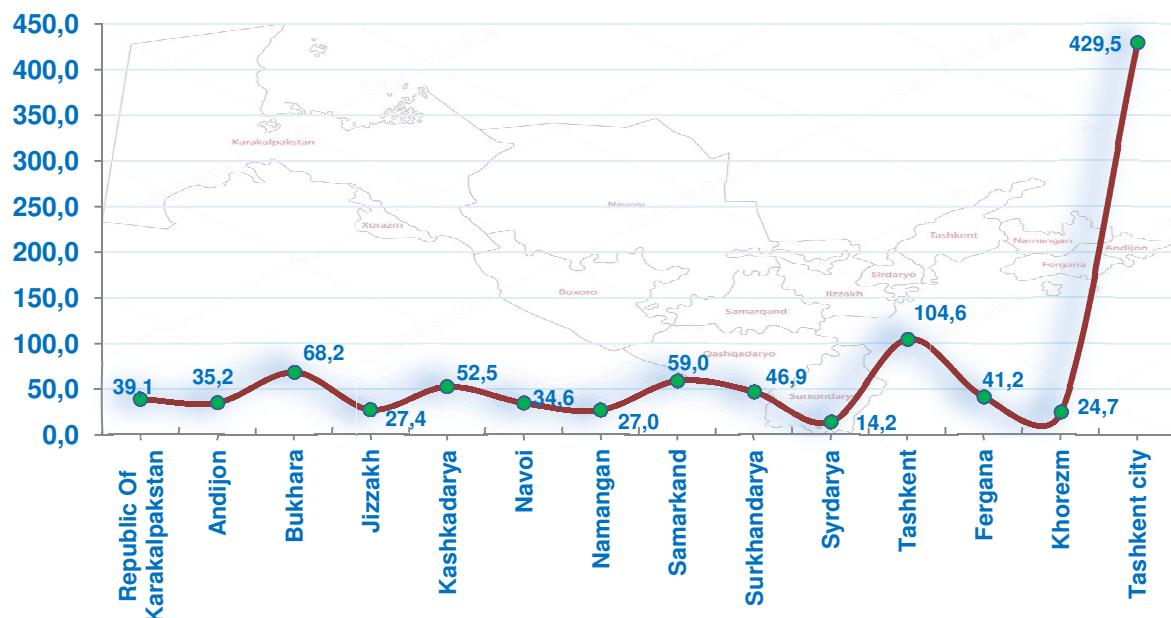

In January-March 2019, the share of trade turnover of public catering enterprises in the structure of retail trade turnover was

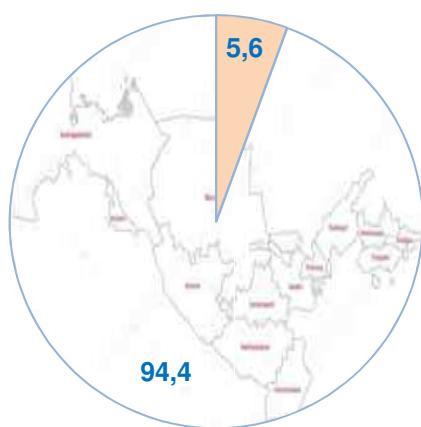

(billion soums)**

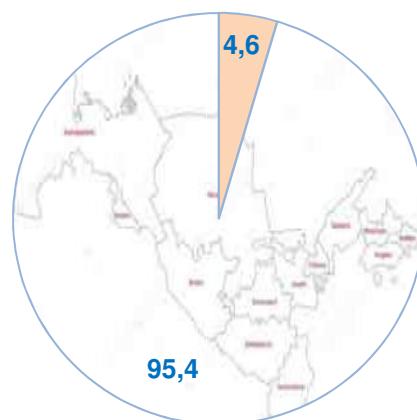


**Share of trade turnover of public enterprises

2018

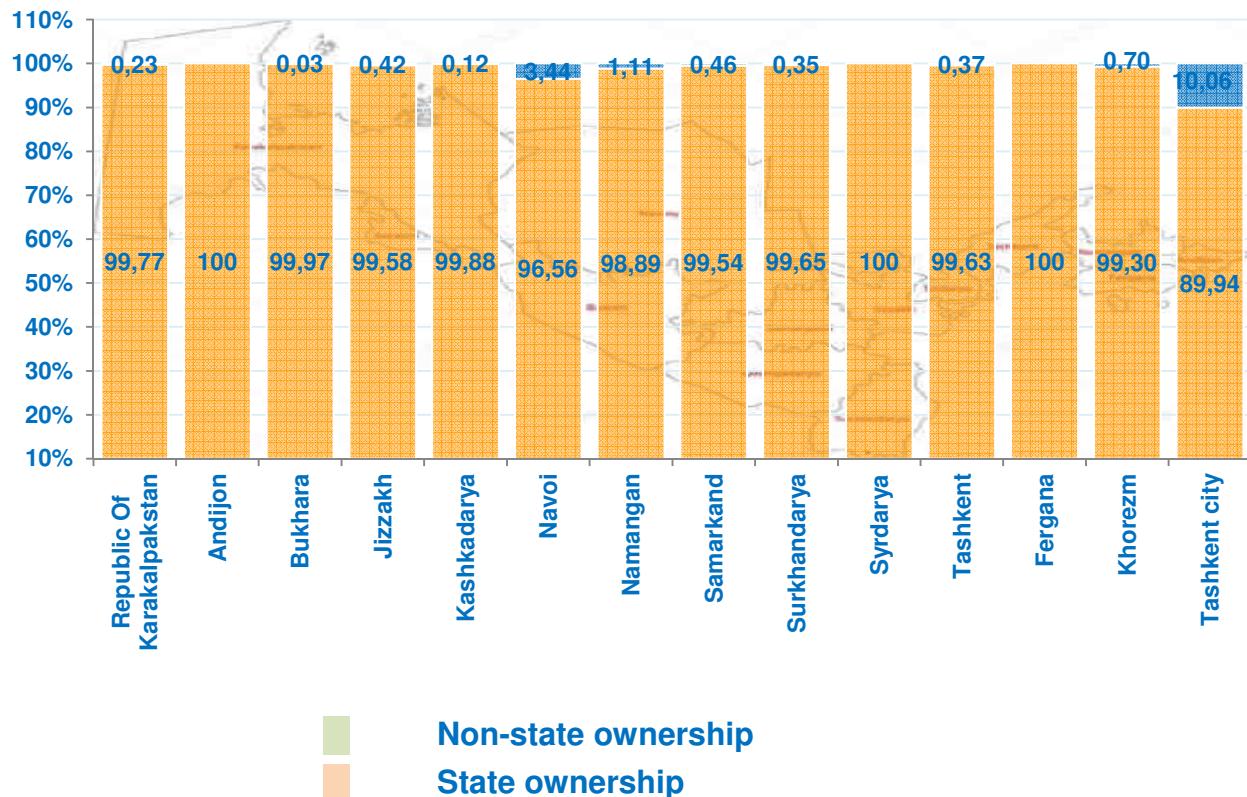

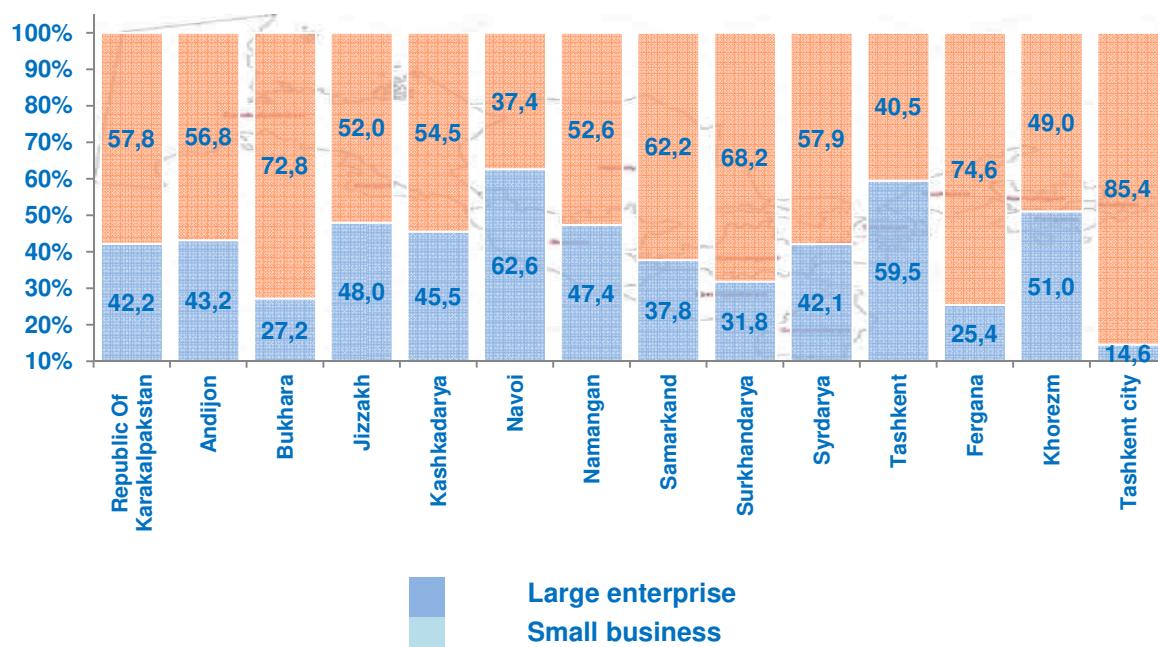
**Wholesale trade turnover in the Republic of Uzbekistan
(for January-March 2019*)**

In January-March 2019, the volume of wholesale trade reached 14 119.3 billion UZS and, compared to the same period last year, an increase of 5.7 %. The turnover of wholesale trade of small businesses, according to statistical calculations, reached 9 772.1 billion UZS and, in comparison with the same period last year, decreased by 0.2 %.

The share of this sector in the wholesale trade turnover in the Republic is 69,2 %. This figure, in comparison with other regions, was higher in Tashkent (85.4%), Fergana (74.6%) and Bukhara (72.8%) regions.

trade turnover, %



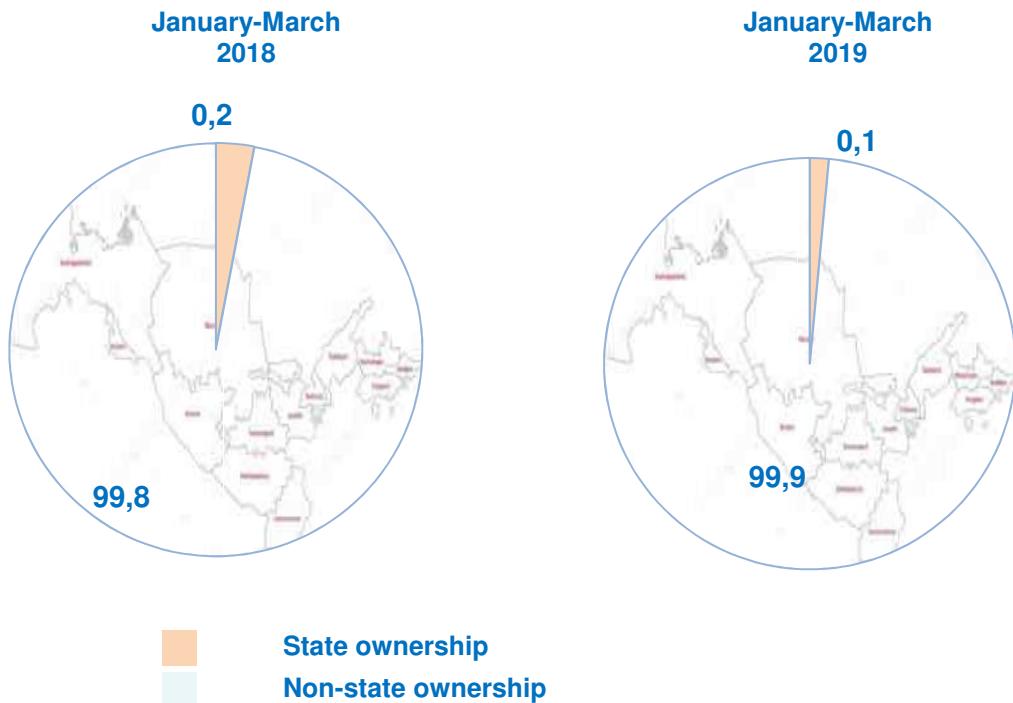

In the structure of wholesale trade turnover, the share of trade turnover of large enterprises is 30.8 % of total sales, while their main share was observed in Tashkent (59.5%) and Khorezm (51.0%) regions.

by ownership, %

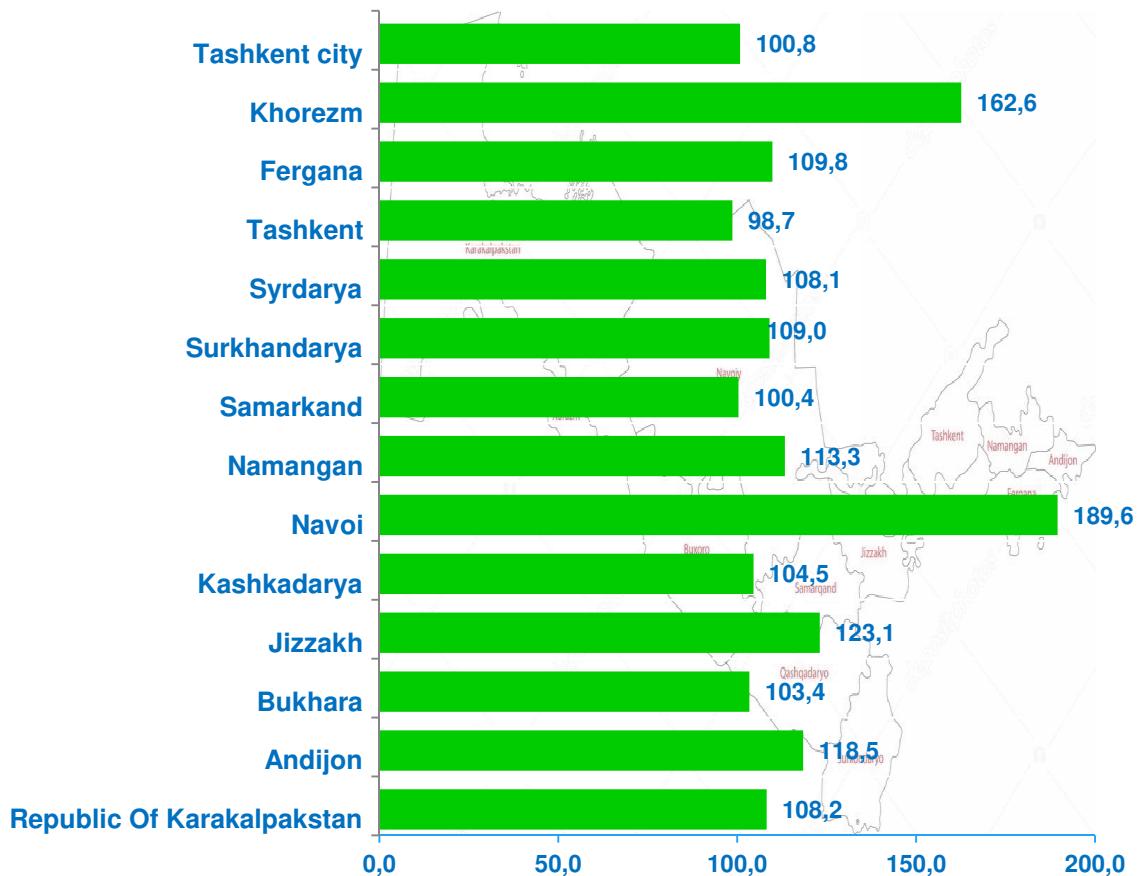

Wholesale trade turnover in January-March of current year has made 14 119.3 billion soums, including non-state actorssubmission – 14 107,0 billion soums, the state submission and 12.3 billion soums. If we compare with the territory of the Republic, the largest share falls on the city of Tashkent - 47.6 %, Tashkent - 10.6 %, Samarkand - 7.5 % and Fergana - 6.0 % of the region.

The lowest growth rates compared to last year in terms of wholesale turnover were observed in Jizzakh (98.7%), Namangan (100.4%) regions, as well as in the Republic of Karakalpakstan (100.8%).
